LAMAR LITTLE LEAGUE WAIVER AND RELEASE

PROGRAM: I/We desire that our child participate in the Lamar Little League baseball program.

RISKS: I/We understand that participation in youth baseball involves inherent risks of injury, maybe serious injury. We hereby assume all risks incidental to youth baseball and acknowledge that injuries to participants of youth baseball are foreseeable.

APPROVAL: I/We, the parents/guardians of the below named candidate for a position on a Lamar Little League team, hereby give my/our approval to participate in any and all Lamar Little League activities, including transportation to and from the activities.

RELEASE AND INDEMNIFICATION: Except as to the extent and in the amount covered by accident or liability insurance, I/We unconditionally waive and release Lamar Little League, its directors, officers, agents, volunteers and/or employees from any and all claims, rights, or causes of action which we now have or may have in the future for any injuries, expenses, loss of compensation, loss of service, or other damages (general, special or damages to personal property) which we may experience as a direct or indirect result of the use of the services, facilities, instruction or premises of Lamar Little League or as a direct or indirect result of our child's participation. **THIS RELEASE SPECIFICALLY INCLUDES AND APPLIES TO ANY INJURIES RESULTING FROM NEGLIGENCE OR ANY NEGLIGENT ACT OR OMISSION ON THE PART OF LAMAR LITTLE LEAGUE, ITS DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND/OR EMPLOYEES.**

I/We know that participation in baseball and softball may result in serious injuries and protective equipment does not prevent all injuries to players, and do hereby further waive, release, absolve, indemnify and agree to hold harmless the Lamar Little League, Little League Baseball, Incorporated, the organizers, sponsors, supervisors, participants and persons transporting my/our child to and from activities for any claim arising out of any injury to my/our child whether the result of negligence or for any other cause, except to the extent and in the amount covered by accident or liability insurance.

Except to the extent and in the amount covered by accident or liability insurance, I/We unconditionally promise and agree to indemnify Lamar Little League, its directors, officers, agents, volunteers and/or employees from any and all claims, rights, or causes of action which we now have or may have in the future for any injuries, expenses, loss of compensation, loss of service, or other damages (general, special or damages to personal property) which we may experience as a direct or indirect result of the use of the services, facilities, instruction or premises of Lamar Little League or as a direct or indirect result of our child's participation. This agreement to indemnify includes any and all money paid or owed by Lamar Little League, its directors, officers, agents, volunteers, or employees to, or are charged by, any person (whether by virtue of a settlement or in litigation) including attorney's fees for any parties to the claim, demand or litigation. **THIS AGREEMENT TO INDEMNIFY INCLUDES AND APPLIES TO ANY CLAIMS, RIGHTS OR CAUSES OF ACTION WHICH MAY BE ASSERTED AGAINST LAMAR LITTLE LEAGUE FOR INJURIES, EXPENSES, LOSS OF COMPENSATION OR OTHER LOSS INCLUDING THOSE ARISING FROM NEGLIGENCE OR ANY NEGLIGENT ACT OR OMISSION ON THE PART OF LAMAR LITTLE LEAGUE, ITS DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND/OR EMPLOYEES.**

EMERGENCY MEDICAL CARE: I/We do hereby authorize any person in a responsible position within the Lamar Little League program, in the event of any emergency, to authorize emergency medical treatment for my/our child named herein. I/We

agree to hold harmless such persons and such emergency care centers (hospital, doctors, nurses, providing such emergency care) for such act and to assume financial responsibility for said treatment.

CONSIDERATION: We hereby acknowledge the validity and adequacy of the consideration for this release being the offering and provision of the Lamar Little League program.

BINDING EFFECT: This agreement is binding upon us and upon our heirs, assigns, dependents, personal representatives, attorneys and our estates. This agreement is also binding upon our child on whose behalf it is executed and upon the legal guardian thereof.

ENTIRE AGREEMENT: This document constitutes the entire agreement between Lamar Little league and the undersigned regarding the subjects covered hereby. All previous agreements, oral and written, are superseded and there exist no further oral or written representations, promises, assurances, or statements of any kind affecting this agreement except those which are expressly set forth in this document.

THE CHILDS NAME MUST BE INSERTED AND THE PARENT OR LEGAL GUARDIAN MUST SIGN BEFORE THE PARTICIPANT WILL BE ASSIGNED TO A TEAM.
