Maine High School Hockey Association 2015 - 2016 Fee and Payment Policies

TRYOUT FEE: The Summer Skills/Conditioning Camp fee is \$375. This fee must be paid in full **before** the player's first skills session and is not refundable. **There will be no pro-rations of this fee.** This fee also includes the Fall Tryout fee. \$100 of this fee will be credited to your Season Fee if the player skates with Maine for the 2015-2016 Season. The Summer Skills/Conditioning Camp fee payment must be included with registration materials including the District 207 waiver and paid by the date of the first on ice session, August 3, 2015. The Tryout fee alone is \$150 and does not include the Summer Skills/Conditioning Camp sessions. **You must attend at least 1 tryout session to be considered for a Fall Maine team.** Payment of the tryout fee is by cash or check only. Checks should be made payable to "Maine High School Hockey Association".

SEASON FEE: The fee for the 2015-2016 is \$3870. This Fee includes all ice for player practices, skill sessions, league regular season and playoff games for the 2015-2016 season, the State playoffs and other related fees. **The fee does not include the player's Jersey, Bags or Sweat Suits**. The Season Fee is not refundable, subject to the Pro-rated Season Fee section below. The fee also contains 2 Tickets for our Annual Fund Raising event scheduled for January, 2016.

PRO-RATED SEASON FEE: Players who are injured may be eligible to have their fees prorated. The injury must be sustained while playing hockey with Maine, and the player must be unable to participate in practices and/or games for at least a six-week period. The maximum discount of fees will be equal to 1/5th of the total fee.

MULTIPLE PLAYER DISCOUNT: Families with more than one skater playing with the MHSHA will receive a discount of 10% off the younger skater's fees. Families with three or more skaters will receive a 5% discount off the combined total of all skaters' fees. The amount of the Multiple Skater Discount will be deducted from the final payment

REFUNDS: Refunds will be made only for overpayment of fees resulting from credits accumulating to a family's account from multiple skater discounts.

PAYMENT OF SEASON FEE:

Payment for the 2015-2016 Season Fee must be made at the mandatory MHSHA coaches/player/parent team meeting to be held in September 2015. Full payment of the Season Fee can be made at that meeting, or the Season Fee can be paid in four installments. The 1st payment (\$1,500) is due at the September parent/player meeting. In addition, post-dated checks for the second, third and fourth installments **must be provided at that meeting.** The 2nd payment (\$1200.00) is due October 15, 2015, the 3rd payment (\$640) is due December 1st, 2015 and the final payment (\$530.00) is due January 5, 2016. A player will not be allowed on the ice to skate with the team until all 4 checks have been delivered to MHSHA.

Goaltender fees are \$900, and may be paid in four installments of \$300, \$200, \$200 and \$200 pursuant to the same terms and schedule described above for skaters. Checks should be made payable to "Maine High School Hockey Association".

A \$25 fee will be assessed for returned checks. Players will not be allowed to skate with their team if season fees are delinquent. A player eligibility list will be provided for the coaches to use.
