## Financial Responsibility Agreement for 2014-2015 Season

The undersigned acknowledges that the Stockton Jr. Colts Hockey Club, total annual fees for the 2014-2015 season are due and payable the week of your first practice. Annual fee classifications are as follows:

**“High School/NorCal Midget League Team”:** Annual fees are One Thousand dollars (\$1,000.00) which include games and ONE(1) tournament entry fee (coach expenses and additional tournament fees are not included).

Family discount: Families with more than one player are entitled to a Two Hundred Dollar (\$200.00) discount for each additional player, up to a maximum discount of \$400.00.

Payment options available: Check the appropriate box.

- 1. Pay the appropriate amount (via check, cash, money order or Pay Pal) IN-FULL by your first practice, the week of August 11<sup>th</sup>, 2014. Choosing this option entitles each player a Fifty-Dollar (\$50.00) discount.
- 2. Accepting the terms of the following payment plan and paying a **\$142.86, (\$114.29 for second or more players) non-refundable**, registration fee at your first practice, the week of August 11<sup>th</sup>, 2014, affirms that the financially responsible party agrees to pay the annual fee in the following installments.

**Credit Cards:** Regardless of whether option 1 or 2 is chosen, payments may be made using a credit card through Pay Pal. The player account will be charged for any fees incurred by the club for such payment.

**Late Fees:** Regardless of whether option 1 or 2 is chosen a Twenty-Five Dollar (\$25.00) late charge will be assessed for each payment received 6 days after the following dates, NO EXCEPTIONS:

There is a \$25 fee for all returned checks. If any form of payment is returned by the bank two or more times a cashier's check will be required for all future payments.

The above fees do not include jerseys or additional games/tournaments, NORCAL or state post-season playoff fees or any post-season practice ice. NORCAL and CAHA fees are included. All fees for post-season playoff, state games and/ice time will be assessed in March 2015.

**The payment option outlined on previous page must be strictly adhered to. Payment is past due on the 21<sup>st</sup> of each month in which those dues become due. If payment is not received by the twenty-second (22<sup>nd</sup>) of the current month, the credit card on file will be charged including a late fee of \$25.00. Should this occur, player accepts responsibility for 3.5% of total run + .15c. Should payment be declined and the account is still delinquent, on the 21<sup>st</sup> of the following month, the player will then become INELIGIBLE to participate in games and practices until the account is brought current. Late fees will continue to be incurred.**

Credit /Debit Cards are not required when paid in full. Financial agreements will be kept on file in the main safe at Oak Park Ice Arena and run on premise as needed. Financial information will never leave OPIA and will be treated with the utmost security.

**PLAYERS IN DEFAULT AFTER DECEMBER 1<sup>st</sup>, 2014 WILL BE PERMANENTLY DROPPED FROM THE ROSTER FOR THE REMAINDER OF THE SEASON.** Being permanently dropped from the roster does not release you from your financial responsibility. Late fees will continue to be incurred.

**UNDER NORCAL RULES, YOU WILL NOT BE ALLOWED TO PARTICIPATE ON ANOTHER NORCAL TEAM UNTIL YOUR DUES TO THE STOCKTON COLTS ARE PAID IN FULL (NORCAL Rules & Regs#4.20.).** The delinquent list is due to NORCAL by June 1st of every year.

I understand all of the above-mentioned items and agree to abide by the rules and regulations as described above. I understand that I am legally bound by this agreement and I am responsible for the total dues mentioned above.
