TO ALL CREDITORS AND EQUITYHOLDERS OF BROADCAST MICROWAVE SERVICES, LLC., AND OTHER PARTIES IN INTEREST:

**PLEASE TAKE NOTICE** that on September 14, 2023 (the "Effective Date"), Broadcast Microwave Services, LLC., (the "Assignor"), a Delaware limited liability company, as assignor, made a General Assignment for the Benefit of Creditors (the "Assignment") to BMS (ABC), LLC, a Delaware limited liability company, solely in its capacity as assignee for the benefit of creditors (the "Assignee"), pursuant to California state law. Accordingly, please use this notice to discontinue any services provided to the Companies effective September 14, 2023.

**PLEASE TAKE FURTHER NOTICE** that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor has no corporate affiliation to the Assignee. Pursuant to the Assignment, the Assignor hereby irrevocably and unconditionally assigns, grants, bargains, conveys, transfers, and sets over to Assignee all of Assignor's currently existing right, title, and interest in real or personal property and all other assets whatsoever, and wheresoever situated, which are now, or have ever been, used in connection with the operation of Assignor's business, and which assets include (without limitation) all tangible and intangible personal property and any interest therein exempt from execution, including any stock of merchandise, office furniture and fixtures, machinery, equipment leasehold interests and improvements, inventory, book accounts, books, bills, accounts receivable, cash on hand, cash in bank (net of amounts necessary to honor checks and wires issued and outstanding as of the Effective Date), patents, copyrights, trademarks and trade names, customer lists, customer contracts, email addresses, all other intellectual property, including without limitation, source codes and passwords, social media account rights and passwords, insurance policies (but excluding any and all policies for Directors and Officers Liability Insurance), tax refunds, rebates, general intangibles including any and all causes of action, insurance refunds and claims (excluding any payments arising out of Directors and Officers Liability Insurance), and choses in action that are legally assignable, together with the proceeds of any non-assignable choses in action that may hereafter be recovered or received by the Assignor, and all real property interests. Further, this General Assignment specifically includes all claims for refunds or abatement of all excess taxes heretofore or hereafter assessed against or collected from the Assignor by the United States or any of its departments or agencies, any state or local taxing authority, and the Assignor agrees to sign and execute a power of attorney or other such document(s) as required to enable Assignee to file and prosecute, compromise, and/or settle all such claims before the respective taxing authority. Assignor agrees to endorse any refund checks relating to the prior operations of said Assignor's business and to deliver such checks immediately to Assignee.

**PLEASE TAKE FURTHER NOTICE** that all persons or entities asserting any claim against Assignor must submit a proof of claim and proper supporting documentation no later than March 14, 2024 (the "Bar Date").
