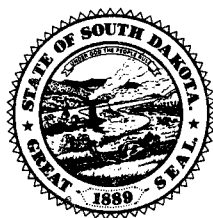

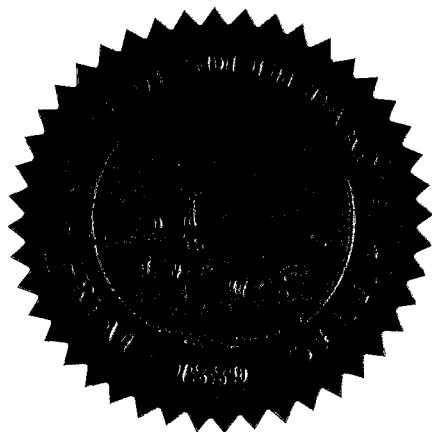

The name of the corporation is Sturgis Soccer Association, Inc.

Article II

The period of existence is: perpetual.

Article III

The purpose for which the corporation is organized.

The purpose or purposes for which the corporation is organized are as follows: To provide the Sturgis area the opportunity to participate in soccer, including providing of fields, uniforms, officials, equipment, and any items necessary to conduct a soccer program; to solicit and involve the community in plans and services that will affect and benefit the soccer program; and, to generally engage in all legal and authorized activities in support of the aforementioned purposes and to generally benefit the citizens of the Sturgis, South Dakota area.

Article VII

Any provisions which the incorporators elect to set forth for the regulation of the internal affairs of the corporation, including any provision for the distribution of assets on dissolution or final liquidation.

In the event of the dissolution of the corporation, all assets remaining after the payment of debts and obligations of the corporation and the expenses of the dissolution shall be distributed to an organization organized for the purposes of carrying on similar activities as set forth in the purposes paragraph of these articles of incorporation.






