**Umpires - -** Motion by Chisago Lakes, Second by East Bethel "Approve the following Umpire fees" Umpire Coordinator Jim Jarvis reported that the fees would remain the same as 2020:

\$115 one man 9 inning game
\$100 one man one 7 inning game
\$200 one man two 7 inning games
\$100 per man, two men one 9 inning game
\$12 per inning for resumption of a suspended game if it is piggybacked to another game.
Hibbing home game fee is as presented above if local Umpires work the game.
If local umpires aren't available and the Umpire is assigned by Jim Jarvis the fee will be:
\$150 one man 9 inning game
\$125 one man one 7 inning game
\$125 one man one 7 inning game
\$125 per man, two men one 9 inning game
The extra fees paid will be reported to the League Secretary/Treasurer to be recorded and used as payment for the following year team league dues.

## **Constitution and By-Law Changes**

Motion by Isanti, Second by Chisago Lakes "To accept the following changes to the Constitution and By-Laws." VOTE: Yes 14, No 0 MOTION PASSED

The By-Law Committee recommended the following changes to the Constitution and By-Laws:

#### Constitution

#### Change Article 3. – Membership - Paragraph 2.

**From:** Each member team must pay annual dues which will be determined each year at the January Organization meeting and maintain a \$135 forfeiture fee reserve balance with the League. The dues payment for new teams will be a two year payment of the amount set.

To: Each member team must pay annual dues which will be determined each year at the January Organization meeting and maintain a forfeiture fee reserve balance with the League based on the current year's game umpire fee plus \$25. The dues payment for new teams will be a two year payment of the amount set.

#### **By-Laws**

### Change Article 4. – Game Rules - Paragraph B.

From: The home team has the final say in determining starting game times and it is recommended to be:

- 1. Night games 7:30 pm for Monday thru Saturday games and 7:00 pm for Sunday games
- 2. Day game start time will be 2:00 or 4:00 pm. Time will be determined by the home team and flexibility maybe needed due to field circumstances.

To: The home team has the final say in determining starting game times and flexibility maybe needed due to field circumstances.

#### Change Article 4. – Game Rules – Paragraph J.

**From:** The MBA official baseballs should be used. Mixing different baseball brands during a game will not be allowed. Visiting team can supply the approved baseballs and will be reimbursed by the Home Team in cash or with approved baseballs. **To:** The official baseball for the Eastern Minnesota Leagues shall be the official ball of the MBA State Tournament (Rawlings flat seem baseball FSRxxx). Unless a different baseball is agreed upon in writing by both Managers.

# Change Article 5. – Playing Fields – Paragraph D.

Delete: All teams must obtain a working scoreboard, not necessarily electric, but one that keeps a running score by inning.

#### Change Article 6. – League Schedule – Paragraph B.

**From:** Rain out games must be rescheduled and played within Four (4) weeks of the postponed game. The exception would be when the rescheduled game is part of a double header that is past the four week period. The League Secretary and the Umpire Assignment Coordinator must be notified immediately of the new date.

**To:** Rain out games must be rescheduled within one week of the postponed game. The League Secretary and the Umpire Assignment Coordinator must be notified immediately of the new date.

# Change Article 6. – League Schedule – Paragraph H.

**From:** Team League game statistics must be entered on the Eastern Minnesota League website. The statistics for batters and pitchers must be entered every Tuesday and include all games played since the last update. A fee of \$25 for each unreported game will be assessed. The league can appoint someone to monitor unless someone volunteers.

**To:** Team League game statistics must be entered on the Eastern Minnesota League website. The statistics for batters and pitchers must be entered every Tuesday and include all games played since the last update. A fee of \$25 for each unreported game will be assessed. The league can appoint someone to monitor unless someone volunteers. A text message or an email must be sent to the person monitoring game statistics.

#### Change Article 7. – Player Responsibilities – Paragraph B.

**From:** No penalty will be assessed for the first ejection during a League game. All ejections after the first ejection during a League game will result in a penalty of one (1) League game suspension in addition to the game he was ejected from. The next League game he attends will be the penalty game and the Player must be in uniform and in the dugout for one game until the penalty is served and he is eligible to play again in a League sanctioned game. However, if the next League game is a forfeited game the penalty is served by the non-forfeiting team. For a Manager and Player/Manager, he cannot be in the dugout when serving the penalty (League sanctioned game). If the game that a Player or Manager is ejected from is their teams last League or League Play-off game, the penalty will carry over to the first League game of the next season.

**To:** No penalty will be assessed for the first ejection during a League game. All ejections after the first ejection during a League game will result in a penalty of one (1) League game suspension in addition to the game he was ejected from. The next League game he attends will be the penalty game and the Player must be in uniform and in the dugout for one game until the penalty is served and he is eligible to play again in a League sanctioned game. However, if the next League game is a forfeited game the penalty is served by the non-forfeiting team. For a Manager and Player/Manager, he cannot be in the dugout when serving the penalty (League sanctioned game).

Region Commissioner – Tom Koplitz was approved by the MBA as Region 1C Commissioner.

League Schedule – Motion by Isanti, Second by Princeton "Teams will play every team in their league twice in their league and teams in the other two leagues once."
