Relayed message from Joe and Jason:

- \*For suspended games - if you're pig tailing that with another game - \$16/inning for the suspended game. If the suspended game is a standalone game, it will be \$150.
- \*Make sure you are checking arbiter - with all the suspended and re-scheduled games.
- \*Home team should let Joe Rydel know of changes - both teams should let Tyler Marcio know for website purposes
- \*Umpires received final bracket for region tournament
- \*Payment to Rich Lindsey from Ham Lake for not being sufficiently informed of postponement - Ham Lake owes the umpire 50% fee (\$75)
- \*Ruling on sleeves for pitchers - no white sleeves on either arm (per Joe)

### **Old business**

- \*If you are postponing or suspending a league game, please let Tyler Marcio know and he will make the appropriate changes. If league games are deleted by anyone else it causes issues with website statistics and standings. You can do what you want with non-league games.

### **New business**

- \*Probably will not need "this" meeting next year moving forward - roster can be reviewed at the end of season/playoff meeting in the future.
- \*Dallas will send out an email as the season nears the end to remind teams to declare their playoff roster (by moving players that will not be on the playoff roster to "inactive" on the website.
