LEAUGE MEMBERSHIP

Twin Ports (see above)

Elk River - Jeff Brooks representative - currently plays for Forest Lake but lives in Elk River - varsity baseball coach reached out about starting an amateur team - day games at varsity field - night games at youth athletic complex with lights

Roster would be made up Elk River players only (wouldn't reach out beyond) - would roster up to about 20.

Motion passes 13-1

The Eastern Minny League has agreed to try and schedule games with Twin Ports to help them get games towards their playoff eligibility

ELECTION OF OFFICERS

Ramsey makes a motion for Dallas Jelmberg to be president of the North and Jayson Pautzke to be president of the South - vice president nomination for Terry Olson for the South and Jim Skroch for the North Isanti Seconds Passed unanimously

New league secretary to replace Jim Brennan Isanti makes a motion to have Dallas Jelmberg become the league secretary/treasurer for the Eastern Minnesota Leagues effective immediately. Chisago Lakes seconds Passies unanimously

Isanti motions that Ben Poidinger continue as webmaster Chisago Lakes seconds Passes unanimously

Rates same - \$150 per 9 inn game (single ump) \$120 per 7 inn game (single ump) \$130 per umpire for a 2 man crew (9 inn. game) Managers please check arbiter consistently

Nowthen makes a motion to keep the league dues at \$250 Chisago Lakes seconds Motion passes unanimously

BY-LAW AND CONSTITUTION COMMITTEE REPORT

By-laws

Article 4 paragraph H

Delete "helmet" as part of coaching attire

Article 4 paragraph S

Delete whole sentence (Base coaches are required to wear helmets when on the field coaching)

Article 7 paragraph A

Add: last sentence of paragraph A - at the end of the final sentence "That player is an illegal player." Just for a bit more clarity.

Add: probably need a paragraph B

There is nothing that speaks to a player being ejected for some other reason other than a dispute with the umpire (for example and illegal slide, fake tag, verbally attaching another player or fans, etc....)

"A player ejection that doesn't involve a dispute with an umpire will result in a minimum of a 1-game suspension and the league reserves the right to add more games if it's deemed necessary."

Add to article 5 of the constitution

"All member teams will vote on all matters that involve the Eastern Minnesota League" - this way we will not have voting in just the "little leagues" (North, South for example)

Mora makes a motion to accept these changes to the by-laws and constitution Nowthen seconds Passes unanimously

PLAYOFFS/REGION

-bids to host regional tournament must be turned in to the regional commissioner by Sun. May 19th

-list provided in advance of players that are "draftable" - streamlines the drafting process -start streaming region tournament ? Look at counting this towards attendance ?

-16 team region - 30 games - may need two sites for the 1st two weekends and just one site for the final weekend - teams need to prepare financially - more games, more \$\$\$\$
