New Business

- Time limits on games
 - 6 inning games are 2 hours drop dead
 - o 7 inning games are 2 ½ hours drop dead
 - Once time has been reached
 - Official scores revert back to the most recent COMPLETED inning
 - If both coaches agree let the kids play out the rest of the inning with no score
 - Recommendation is that both coaches sign the score books with official score BEFORE continued play
- 10 run rule
 - **REMINDER!!!** We are a rec league designed to foster the love of the game and **NOT** just winning. Please use a level of sportsmanship.
- 8u Baseball
 - No tic line is in effect
- Coaching Staff
 - It is the responsibility of the organizations to collect clearances on coaches
 - There is a limit of 4 coaches per team with the exception of 1 score keeper
 - These coaches need to be rostered as such
- **REMINDER!!!** NO parents or spectators should be on the field of play OR in the dugout for **ANY** reason.
- Playoff Forfeit

- If for any reason a team is forced to forfeit a game during the playoffs that team will automatically be out of the playoffs completely
- Disputing an officials call
 - ONLY the head coach can dispute a call
 - Any member of the coaching staff can call a timeout and discuss with a head coach
 - If necessary both head coaches and officials will converse together in close proximity to one another there will be no arguing calls across the field.
- 10u SB
 - 1st inning is developmental for pitcher
 - Run limit is 3 runs (innings 2-5 are 5 runs; 6th inning unlimited)
- If a pitcher hits 3 girls in a single inning she can not pitch anymore that game
- If the ball hits the ground before crossing the plate or making contact with the batter it should be called a ball for count purposes
- All players must have at least 1 inning of infield playing position
 - The only exception to this rule is player safety.
 - If a coach has a great concern for a players safety during infield play that **MUST** be communicated to the opposing head coach **PRIOR** to the start of the game.
- Spring 2024 rosters MUSTbe electronically completed and submitted on the online roster sheet.
 - <u>NO</u> pictures or text messages will be accepted
 - o NO handwritten rosters will be accepted
 - Due <u>BY</u> March 31, 2024 at 11:59 p.m.
 - Preferably by March HAAA meeting
 - Schedules will be inputted into the software that week
- Special circumstance form is available on the website and can be sent to the same email address listed on the rosters form
- Bylaws have been updated
 - Article 7 was removed
