        - o If a 15u team is available 13-year-olds MUST play 15u
        - o 13-year-old pitch maximum of 1 inning in 12u
  - Rosters will be electronic only and must contain First and last names, address, phone number as well as
    - If the player is out of area
    - If the player plays for the school district (13u and above)
    - Msut be labeled with Head and Assistant coach names and info
    - Due April 3, 2023
      - It was discussed that if a player is added after rosters are submitted that player MUST play 50% of SCHEDULED games to be playoff eligible
    - Coaches must inform coordinators of injuries ASAP
