## 3) New Business

- a) Fields:

- b) Discussed split schedule for 53 for 2016.
- c) Rules:
  - i) Rewrite Rule 1.01 - Players who are removed from the offensive line up via an **injury runner** cannot re-enter the game in any capacity. (Should Read via Injury)
  - ii) Rewrite: Line up card is the official document to determine batting order. (Not once through the line up)
- d) Schedules

- i) Discussed a variety of options for unbalanced schedule in 53s – i.e. like A/B playoff.
- ii) Hope to be able to eliminate bracket play in 45s to make it easier. Maybe extend season.
- e) Marketing
  - i) Discussed opportunities i.e. Walmart – hand out fliers
  - ii) Ramsey run radio spot.
- 4) Motions
  - a) Passed: Number of members on EC reduced from 8 to 7.
  - b) Passed: Team deposit of \$500 due December 15, 2015.
  - c) Passed: John Wilson nominated to be new board member.
  - d) Passed: Player Pool in season new signups will be assigned to the last place team - bottom of list. They have one week to keep or pass to the next team. If taken then they go to top of list.
  - e) Passed: Forfeit will result in all players getting credit if the game is in progress. If game is not in progress then winning team gets credit while no players from losing team get credit.
