# EC Meeting Minutes.



Type of Meeting: Executive Committee

#### Organizational

1. Executive Council (EC) of St Louis Baseball Forever League (STLBFL)has been increased to 8 at the suggestion of the state of Missouri (state of incorporation).

- 2. EC agreed to have Rick Bergman, Mark Karpinski and Darryl Dickerhoff meet as a sub-committee to review the ByLaws and Rules and return to the EC with their recommendations. It is expected that some of these changes will require a vote of the managers.
- 3. It was agreed that the EC will operate in a mode of transparency where all meeting decisions and financial information will be fully disclosed to the mangers and players.
- 4. EC agreed that material changes to the operation of the league, ByLaws and Rules would be submitted to the managers for their vote and ratification.
- 5. Discussed E&O insurance for EC. Assigned to Gene Mehrtens to investigate and report.
- 6. The STLBFL has been approached by the former MSBL/Johnny Mac league to consider merging the 45 divisions. The EC agreed to table all discussions for the 2014 season.
- 7. The election of EC was recognized as:

#### **Financial**

- 1. While the financial transactions for the 2013 season are not finalized, we expect to finish 2013 with an \$8,000 surplus. The ByLaws require that we keep a carryover which is \$4,000 this year. The remaining \$4,000 will go to the 2013 participating teams as a credit against their 2014 fees or a refund check.
- 2. More complete financials are being prepared but a preliminary highlights of expenses would include:

- 3. The EC approved spending \$700 for the championship jerseys.
- 4. EC voted to renew HTO (Home Team Online website) fees.
- 5. EC agreed that one signature was adequate but that Wood and Mehrtens be added to the signature card along with Dickerhoff.
- 6. EC agreed that managers need to deposit \$500 with the league by January 15 to secure a spot for the 2014 season.

### Teams, Players and Umpires

- 1. Two teams have applied to STLBFL. The 45 Stallions will be moving to the 53+ Division as the Patriots. The Owls will form a new 53 team. No EC approval is needed for existing teams. This will bring the 53 Division to 11 teams.
- 2. The EC approved the number of games for 2014 subject to managers approval.
  - a. 45 Division 25 Games
  - b. 53 Division 30 Games
- 3. There was a general discussion on quality of Umpires going into the last year of our agreement. Marty Ribaudo will meet with umpires organization and report back.
- 4. The EC agreed to support the new 60+ Division provided 3 teams could be organized and put in place. Further discussions included:
  - a. Playing 7 innings instead of 9.
  - b. Playing a 10 games schedule starting in June
  - c. All game scheduled for Sunday afternoon.
  - d. Allowing exception players 59 as non-pitchers.
  - e. Gene Mertens and Marty Ribaudo will spearhead and report back to EC.
- 5. The probation status was dropped for four teams; Game Face, Grays, Sharks, Colt 45s.
- 6. Player Pool. After much discussion, EC decided to investigate alternatives to ensure that all managers will be notified when a new player registers and procedures will be established to encourage parity. Article VII.F.a,b,c.

#### Scheduling

- 1. EC approved generic scheduling for 2013. A generic schedule (team 1, team 2, team 3) will be prepared. At the scheduling meeting managers will draw their schedule from a hat. We will then give everybody 30 minutes to consider trading their entire schedule with another team.
  - a. After this initial schedule day, we will have another schedule meeting where teams will be able to swap dates with other teams.
- 2. Rain Outs; teams will have 72 hours to reschedule a rainout from the rainout dates published on the website link. After that the Chairman of Fields, Scheduling and Tournaments will select a date that cannot be contested.
- 3. A number of playoff scenarios were discussed. The EC did agree that the playoff scheduling should be done at the start of the season.

## **Rule Changes**

1. EC voted to table discussions on extending the game time limit until financial impact (umpires, fields) has been evaluated.

- 2. EC will put the age limit of the 53 Division to a Manager's vote. The current By-Laws state that the age limit of the 53 Division will go to 54 in 2014 and then 55 in 2015 where it will stay. The managers will vote on:
  - a. Keep age requirement at 53 and retain the two 52 year old exceptions.
  - b. Keep age requirement at 53 and grandfather last year's exceptions but do not allow new exceptions.
  - c. Change the age requirement to 54 and allow two 52 year old exceptions. (current rule)
- 3. EC approves the Shared Lineup rule used by Roy Hobbs World Series.
- 4. EC recommends that player attendance discrepancies be subject to 3 game suspensions for manager and player. This will be addressed in the rules modifications (Organizational #2).
