BY-LAW : WAIVER of PLAYER-COACH REGISTRATION FEE

Effective with the 2012 baseball season (**January 01 – 2012**) the Tecumseh Baseball Club (Executive and/or Board of Directors) will WAIVE **ONLY** the basic and/or standard registration fee for individuals that are identified with the designation as PLAYER-COACH . All other required association or team related fees (perks , tournament accommodations , travel expenses , OBA certifications and levels , etc.) will remain the sole responsibility of the Player- Coach . To qualify for approval of this waiver from the Tecumseh Baseball Club the Player - Coach must submit a written request two weeks prior to the start of the REGULAR season . In addition to the normal player-coach information , the written request must also specify which

General approach – NO Refunds

1. Requests for refund with specific rationale must be made to the BOD or the association President in writing and if necessary followed with a BOD mtg with requestor or representative .

2. Possible accepted reasons ;

season ending injury(with 50 percent or more of regular season scheduled games remaining) ********

- relocation that consists of moving further than 75 kilometers ********
- new job or employment parameters / criteria prevents the player from attending (new hours , relocation , stressful added responsibilities) ********
- family or marital issues and/or problems (divorces, deaths, caretaker responsibilities) ********
- hardship financial cases (bankruptcy house fire) ********

****** ALL REQUESTS WILL BE REVIEWED AND JUDGED ON INDIVIDUAL MERIT AND CONDITION and PRORATED as determined by the BOD ******

UNACCEPTABLE REASONS

- (a.) Parent or player unhappy with playing time or position (s)
- (b.) Parent or player unhappy with coaches / manager or TBC
- (c.) Parent or player want to transfer to another association
- (d.) Player cannot find or organize regular transportation to and from games.
- (e.) Player no longer interested in playing
- (f.) Parent or player dissatisfied with team perks.
- (g.) Parent or player unhappy with the number of tournaments participation.
- (h.) Parent or player can't afford tournament expenditure.
- (i.) Player suspended by OBA or SPBA due to his own accord and actions
- (j.) Player or parent dissatisfied with player's visibility and access to scouts reviews and assessments of the player's ability and potential to advance and/or achieve scholarship nomination.
