AYFCO **Probationary Process**

Probationary Association or Team:

- a. Any association or team seeking to become a probationary association or team must fill out submit a completed Probationary Membership Application form and submit in writing a request to be considered for probationary membership.
- b. The General Board shall consider the request and by majority vote approve (in full or with special conditions and/or requirements). If approved the Association/Team will be under a probationary mentor assigned by the General Board
- c. The probationary period will be for one football season—Associations have no voting rights during the probationary football season.
- d. After one year without incidents (violation of bylaws and/or code of conduct) and being in good standing, the Association/Team may request at the end of the probationary period to be a full fledged member of AYFCO with all the privileges due respectfully as an Association or Team per AYFCO bylaws.
- e. The General Board shall consider the request and vote by 2/3 majority vote to approve the request. If the request is rejected, the Probationary Association may be granted one more year to become an Association/Team in good standing.
- f. Probationary Associations/Teams can be removed at any time from the league by a simple majority vote of the General Board.
