The Federal Way Junior Football Assoc. is a recreational program designed to teach children between the ages of 6 and 14 the basic fundamentals of football and cheerleading in a fun, safe, team-oriented environment. While we encourage our coaches to strive to win, winning is not an important goal of the league and should not be a primary goal of the coach. Our goals are to teach football & cheerleading, have fun, exhibit good sportsmanship and play fair, promote teamwork and encourage physical activity and fitness.

Volunteers are the backbone and the heart of our organization. We could not function without dedicated people at every level of the organization. The interaction between coaches and players, the ability to teach game skills and the psychological effects of coaches' actions toward their players, can create impressions on youth that can last a lifetime. For these reasons, the Federal Way Junior Football Assoc. carefully screens, conducts background checks and trains its volunteers before they are permitted to be associated with children. All interactions with our youth should be conducted in a manner that reflects positively on yourself, your franchise and our League. In compliance with RCW 43.43.830-845, all applicants who have been offered a position as a volunteer, and in which position the person may have unsupervised access to children under sixteen years of age, to developmentally disabled persons, or to vulnerable adults, are required to disclose the information requested on this form. Failure to provide this information may disqualify you from a volunteer position.

If you do not agree with this philosophy, or are not willing to sign this statement, then we ask that you not complete the remainder of this form.

I understand that I will be required to produce photo identification (driver's license or state issued identification card) and/or Social Security card to positively establish my identity and that a photocopy of the identification provided will be attached to this form. I authorize the Federal Way Junior Football Assoc. ("the Franchise") to make such investigations and inquiries as necessary in arriving at a volunteer placement decision. I understand that the Franchise will inquire to the Washington State Patrol and/or a National Background Investigation Agency regarding my criminal history and conviction records, disciplinary board final decisions, or civil adjudication records. I understand that information provided from such individuals will not be made available to me and that the information I provide is for FWJFA use only. I release and hold harmless the Franchise and it's teams, from any and all liability in responding to inquiries in connection with my application.

Any offer of volunteer placement is contingent upon an acceptable outcome of the criminal records check. I agree that the Franchise may, at its discretion, preclude me from volunteer service if, among other reasons, I provide misleading or incomplete statements. I understand that I am required to abide by all policies, procedures and by-laws of my franchise, and that if appointed, I understand that, prior to the expiration of my term, I am subject to suspension and/or removal for violation of franchise or Greater Puget Sound Youth football rules, policies ~~or~~ policies. I understand that if I am accepted as a volunteer, an identification badge will be issued and that the badge will be required to be worn during franchise and League activities.

I acknowledge that I have read this entire Notification and Authorization for Background Investigation Disclosure Statement. I understand the requirements, and I grant permission to the Federal Way Junior Football Assoc. to make inquiry to the Washington State Patrol under the provisions of this law pursuant to RCW 9A.72.085, and/or a National Background Investigation Agency. I certify under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.
