FACTS ABOUT FUN FOOTBALL

- CERTIFIED AS AN IRS 501C3 TAX EXEMPT CORPORATION.
- CONTINUES TO BE AN EFFECTIVE LITTLE LEAGUE ORGANIZATION.
- FUN FOOTBALL'S SUCCESS IS DUE TO BEING MANAGED BY COMMITTED. LEAGUE MEMBERS AND FOOTBALL ORGANIZATION PRESIDENTS.
- TYPICAL FOOTBALL SEASON INVOLVES 8 REGULAR SEASON GAMES AND PLAYOFF SYSTEM THAT RESULTS IN A LEAGUE CHAMPIONSHIP (SUPERBOWL) AND ROSE BOWL (3RD & 4TH PLAYOFF TEAMS COMPETE).
- CONTRIBUTED TO THE DEVELOPMENT OF MORE THAN A DOZEN SUPERBOWL PLAYERS AND HUNDREDS OF DIVISION 1 COLLEGE PLAYERS.
- TYPICAL DRILL/CHEER SEASON INCLUDES GAME PERFORMANCES AND THE ANNUAL DRILL BOWL.

- JV (10 & UNDER) & VARSITY (12 & UNDER)

FEEES

\$800 FIRST YEAR FRANCHISE

- FEE COVERS COST OF SUPERBOWL, ROSE BOWL, DRILL BOWL, ADMIN COSTS OF REGISTRATION, WEBSITE & PARTICIPATION BY ALL PLAYERS AND CHEER/DANCE.
- NO PER PLAYER OR CHEER FEE

ADVANTAGES

- STRUCTURED ORGANIZATION WITH STANDARDS & EXPECTATIONS OF PROPER CONDUCT.
- OPERATED BY GOVERNING BOARD (NO ONE INDIVIDUAL MAKES CRITICAL DECISIONS).
- CONTROL FOOTBALL STADIUM WHERE MEMBER TEAMS CAN PLAY HOME GAMES WITH FACILITY DEDICATED PERSONNEL.
- STRICT RULES ENFORCEMENT ON PLAYER ELIGIBILITY.
- ALL LEAGUE FUNDS ARE USED FOR FOOTBALL AND DRILL TEAM SUPPORT, NO MONEY IS RETAINED BY THE LEAGUE.
- PRE-SEASON JAMBOREE.
- SUPERBOWL CONTESTANTS SHARE ALL GATE FEES, (IN 2023, \$1000 PER TEAM PAYOUT)
- ROSE BOWL CONTESTANTS SHARE IN PROFIT FROM GAME.
- OUTSTANDING DRILL/CHEER COMPETITION.
