



Skills & Drills Waiver Form

The term "Participant" as used herein shall mean children playing in LOUYAA sports programs, and their parent(s) or legal guardian. As the parent or guardian of the child(ren) I am registering for LOUYAA sports programs ("Program"), I expressly authorize my child(ren)'s participation in such programs and all activities that are part of or incidental to such programs. As part of the registration of my child(ren) in the Program, and in consideration of the services to be provided by LOUYAA to my child(ren), I hereby acknowledge and accept the following terms and conditions pertaining to injuries or death that may arise from my child(ren)'s participation, with full knowledge, understanding and appreciation for the risks involved.

I expressly and personally assume all risks of injury or death to my child(ren) that may arise from their participation in the Program, and all risks and liability for injury or death that may occur to other Participants in the Program as a result of my, or my child(ren)'s, intentional or negligent acts. Football, baseball, soccer, basketball, lacrosse, field hockey, golf, softball, speed and agility training, cheerleading, and poms are dangerous sports that involve various levels of physical strain and contact with other players and/or with sporting equipment such as bats, balls, goals, helmets and cleats, and serious injury or death may result from participation in such sports.

LOUYAA, and its officers, directors, agents, employees, representatives, contractors, consultants, staff, volunteers, successors and assignees are not responsible or liable for the negligent or intentional acts or omissions of Participants. I hereby waive any claims that I may have for myself or my child(ren) against LOUYAA or its officers, directors, agents, employees, representatives, contractors, consultants, staff, volunteers, successors and assignees, that may arise out of my child(ren)'s participation in the Program, and any injury, including death, resulting from such participation, and release LOUYAA and its officers, directors, agents, employees, representatives, contractors, consultants, staff, volunteers, successors and assignees, from any and all damages, losses, liabilities, costs, and expenses resulting from any injury or death and claims arising therefrom.

I, as the parent or legal guardian of the Participant, hereby forever indemnify and irrevocably agree to defend and hold harmless LOUYAA, and its officers, directors, agents, employees, representatives, contractors, consultants, staff, and volunteers successors and assignees from and against any liabilities, losses, costs, and damages that may arise out of my or my child(ren)'s acts or omissions.

This indemnification is in consideration of the Participant's enrollment in the Program and is made knowingly and voluntarily. The waivers and releases set forth herein shall be binding upon the personal representatives, agents, heirs, and estates of the Participant.

LOUYAA reserves the right to reject any applicant and to deny anyone enrollment in the Program. LOUYAA further reserves the right to terminate the enrollment of any Participant at any time after accepting their application, for any or no reason. By completing this application I am accepting these terms and conditions and agree to be bound by them, and by any rules, regulations, and bylaws of LOUYAA, as well as by the decisions of its commissioners and Board of Directors.

I hereby authorize LOUYAA, and its staff, coaches, and volunteers, to render emergency first aid to my child(ren) in the event of injury. I further authorize LOUYAA, and its staff, coaches, and volunteers to act as my agent for

the purpose of authorizing emergency medical, dental, or surgical examination or treatment, until a legal guardian can be contacted.
