# P. O. P. CRUSADERS FOOTBALL LLC PLAYER CONTRACT

Player has the physical and mental qualifications and skills required to participate in the activities and events sponsored, sanctioned and/or hosted by the Team.

The team has chosen the Player to be on Team's active roster, and Player has agreed to be on the Team's roster, for the purposes and on the terms and conditions set forth below, on an exclusive basis.

## **AGREEMENTS:**

For the reasons set forth above, and in consideration of the mutual agreements set forth below, the parties agree as follows:

Player is to fulfill duties and responsibilities described in the position description below.

Player will not receive any financial compensation by the Team in any manner whatsoever for the duties and tasks he performs for the Team during any game, event, activity, etc. that is sanctioned by the Team and/or organized league of play that the Team is an active member. Player's status with the Team is strictly as an amateur athlete and/or football player.

#### **RELATIONSHIP OF PARTIES:**

Player is Not an Agent, Employee or Servant, but rather that of an amateur adult athlete. The parties expressly agree that the relationship intended between Player and Team shall be that of an adult amateur athlete only and that this Agreement is not intended to create the relationship of a principal and agent, employer and employee, or master and servant. Player is now and will continue to be an adult amateur athlete.

**A. Player Registration Fee**. Upon the discretion of the Team, a registration and/or "tryout" fee can be charged to a player in addition to any other fee(s) the Team may deem necessary to charge each player for the participation and activity with said team. There is no minimum, or maximum, that the team can charge a player for a try-out fee.

- **B. Player Participation Fee**. Player shall be responsible for payment to the Team for a "Player Participation Fee". Said fee, at the discretion of the Team, can be submitted to the Team in various increments accepted by the Team. Said fee amount(s) are non-refundable, may be no less than \$100 in personal, private, public or commercial donation/sponsorship funds. Fee(s) related to lodging, travel, facility rental, and/or game officials are separate and/or independent of said fee(s), and are not considered any part of same.
- **C. Player Health Insurance**. No health, disability or personal injury/accident insurance shall be obtained by the Team for any player on the Team roster. Player is responsible for the purchase of his own health, disability or personal injury/accident insurance.
- **D. Non-Compete**. Player is the athletic property of the Team, and is prohibited from participating as a football athlete on any other adult amateur team's roster and/or organization of similar stature in a game or event that is not approved and/or authorized by the Team. Such authorization must be in writing approving and/or authorizing release of Player from the Team.
- **E. Breach of Contract**. Any action determined to be that of a breach of this contract by the Player gives the Team the right to declare said relationship and contract "breached" (violated). the Team reserves any legal right(s) and/or remedies allowable and/or available by the laws of the United States, or any state within the United States, including the state of Florida, and/or any province within Canada, to pursue financial compensation from the Player, and/or any outside and/or independent party determined, or alleged, or suspected, to be responsible for the willful and deliberate act of violating any terms of this section and/or agreement in association with the Player, for the time and/or expenses incurred upon the Team for the training, coaching and game experience enjoyed by the Player prior to breaching and/or violating the terms of this section and/or agreement.
- **F.** This contract is not assignable.
- **G.** This contract contains the complete agreement of the parties concerning the athletic participation by the Player or for the purposes set forth above and supersedes all other agreements, both oral and written between the parties.
- **H. Transportation**. Upon request by the Team, the Player will be responsible for his transportation to, and from, all Team games, activities, meetings, practices and events as sanctioned by the Team and/or the league of play that the Team is an active member of. When applicable, the Team may assume the responsibility of providing transport to, and from, various games, practices, events, meetings and activities as sanctioned by the Team and/or league of play that the Team is an active member of. There may be times when the Player is requested by the Team to assist with a financial donation in order to requisition a mode of transportation to, and from, any game, practice, meeting, event, or activity as sanctioned by the Team and/or League of play that the Team is an active member of.

**I. Player Release**. Player can request his release from this contract on the basis that he has not played and/or received any significant time on the field of play during any regular season game. "Significant" time will be determined by Team officials upon an appeal to such through Players Association of the P. O. P. Crusaders Football LLC. In the event that there is no Players Association to appeal through, then player is to appeal directly to the President of the P. O. P. Crusaders Football LLC A Player can also request a release from this contract in the event that he has received an offer to participate on the roster of any sports team and/or franchise as a "professional" athlete, and thus rendering his tenure with the Team as permanently terminated. A player who is forced to cease his active participation with the team due to vocational/career reasons that are non-associated with the sport of football, is considered to be "inactive", but not released, thus remaining the property of the Team, unless the Team provides the player with their written release in accordance with rules of the P. O. P. Crusaders Football LLC.

## **POSITION RESPONSIBILITIES:**

- **A.** Player is to actively participate as a football athlete in all team meetings, practices, events and games as sanctioned by and/or hosted by the Team.
- **B.** Player is to actively participate in all Team fundraising activities, events, community service projects, etc. as sanctioned by the Team.
- **C.** Player will adhere to, and comply with, any and all rules, regulations, guidelines and code of conduct as set forth by the Team, and the United Football Federation during the tenure of this agreement.
- **D.** Player will adhere to, and comply with, any and all rules, codes, regulations, guidelines and protocol as set forth by any commercial enterprise that is providing a service to the Team and/or United Football Federation in the capacity as a vendor for such service(s) related to, but not limited to, lodging, transportation, food/meals, communication, fuel, equipment, uniforms, field of play (practice, game, or otherwise), parties/events, etc.
- **E.** Player will adhere to, and comply with, any and all local, state and federal laws, ordinances, codes, regulations and guidelines as set forth by any applicable jurisdiction and/or government agency responsible for enforcing such.
