Each cheer squad is required to have a minimum of 2 adult coaches (over the age of 18). The MLS board will make a determination on the number of coaches per team based on total number of participants and discussion with the head coach.

Each football team is limited to 4 adult coaches (over the age of 18). The MLS board will make a determination on the number of coaches per team based on total number of participants and discussion with the head coach.

If/When approved and appointed by the MLS Board, your coaching application / position will be temporarily approved, contingent on the MLS Board receiving a current PA State Criminal History Report, PA Child Abuse Clearance and if you have not lived in PA for 10 continuous years a Federal Criminal History Report.
