By participating in the F.G.H.L, the Participant grants its permission to the Releases (and any of them) to take photographs of the Participant and /or to use the Participant's name, likeness or any other identification for advertising, marketing, publicity, instructional or other purposes' in connection with the F.G.H.L and/or the Facility and/or any related activity of any of the Releases, in any medium at any time and from time to time, without compensation and without right of prior review or approval by the Participant (except where prohibited by law).

By participating in the F.G.H.L, the Participant consents to the collection by the F.G.H.L of his/her personal information on this form and to the disclosure of such personal information to third parties, as required, including legal and insurance companies, in each case to the extent permitted or required by applicable laws

The release shall endure to the benefit of the respective heirs, next of kin, executors, administrators, successors and assigns of the Releases and shall be binding on the Participant and the Participant's heirs, next of kin, executors, administrators, legal personal representatives, successors and assigns.
