



Glenbard Hockey Club 2023-2024 Fall Season Financial / Payment Terms

This Agreement revised on July 10, 2023 is made effective and binding between the Parent/Guardian and the Glenbard Hockey Club ("Club") when your first payment is made. The Club is currently classified as a "combined" high school hockey team, as defined by the Amateur Hockey Association of Illinois (AHA). For the 2023 / 2024 high school hockey season, the Club is comprised of four different high schools, Glenbard North H.S., Glenbard East H.S., Glenbard South H.S. and Glenbard West H.S. Parent/Guardian and Player agree that Player shall play for the Glenbard Hockey Club for one full season. Parent/Guardian & Player agree that the Player shall be actively involved with the Club's team by participating in all scheduled practice sessions and games in which a player is called upon to participate (unless unable to do so due to medical or educational reasons, or another valid reason), which must be communicated to and approved by the team head coach in advance of the scheduled practice and/or game.

2023/24 FEE'S:

2023/24 SKATER FEES: 1 TIME PAYMENT OF \$4,200.00 or 4 PAYMENTS OF \$1,112.50 = \$4,450.00. ***All 1-time payments will receive a raffle ticket for the Holiday Skate \$500.00 Raffle***

2023/24 GOALIE FEES: 1 TIME PAYMENT OF \$2,600.00 or 4 PAYMENTS OF \$700.00 = \$2,800.00. ***All 1-time payments will receive a raffle ticket for the Holiday Skate \$500.00 Raffle***

Per AHA requirements for combined clubs, the Glenbard Hockey Club is required to accept all applications that meet the Club's try-out policy and is not permitted to reject a player eligibility unless for personal safety reasons (that would require prior approval by an AHA Board representative). Any player planning to roster with one or more teams, in addition to the Glenbard Hockey Club, is required to submit in writing (to the GBH Hockey Director) their intent to "double roster" with another USA Hockey registered organization at the time of registration for team tryouts.

Parent/Guardian and Player agree that the Club shall have the right to suspend Player at the discretion of the Club's Board of Directors in accordance with the Club's by-laws and Rules and Ethics Policy. Parent/Guardian and Player agree that, for Player to remain on the team, Parent/Guardian and Player must (1) commit no act detrimental to the sport of ice hockey, the Glenbard Hockey Club or the team; (2) comply with all provisions stated in this Agreement; and (3) abide by the Club's by-laws, Rules and Ethics Policy as well as all the Rules and Regulations of USA Hockey and Amateur Hockey Association Illinois (AHA) and IL West Hockey League.

Upon being officially placed on a Glenbard Hockey Club Roster (posted on the Glenbard Hockey Website) the Parent/Guardian agrees to set up automatic billing for the pre-determined Fall Fee amount (Skater / Goalie) by the end of the 1st week of September (in the same year of the season to be played). CC payments that are set up for future billing and are declined, could result in an additional fee of \$50 per instance and the immediate suspension of the Player from all Club and team activities until Parent/Guardian has resolved the situation to the satisfaction of the Club.

All Parent/Guardians and players agree they shall submit all necessary forms, including but not limited to (a) USA Hockey Online Program Participation Registration; (b) Club Registration Form online; (c) Club Waiver and Release of Liability form; (d) AHA High School Hockey Participation form; (e) Club Hockey Player Code of Conduct form (to be signed by both Parent/Guardians, where applicable); (f) Rules and Ethics Policy; (g) Letter of intent to "Double Roster" with another hockey team in addition to the Glenbard Hockey Club.

Parent/Guardian and Player agree and understand that the Club Fees are intended to cover all Glenbard Hockey Club Expenses, I.E.: Ice costs, Salaries, Tournaments and general expenses. Any additional costs, outside of the scheduled games, practices, tournaments are the responsibility of the Parent/Guardian, for example, additional tournaments, player transportation, hotel accommodations, meals, equipment, warm-ups, or game Jerseys, just to name a few

Once a Player has been officially placed on a Glenbard Hockey Club Team Roster and a Parent/Guardian sets up their automatic billing schedule online, Parent/Guardian understands that no refunds will be issued if any Player withdraws from the Club for any reason. By accepting a roster position and setting up your payment plan with the Glenbard Hockey Club, it is agreed by all parties involved that any/all payments made will be forfeited and **no refund or any portion of any payment(s) made will be refunded by the Glenbard Hockey Club.**

Hockey is a play at your own risk sport, we cannot stress safety first enough, we never wish any injury for any player within our club. In the case of a season-ending injury that is sustained **during a scheduled Club practice or game**, the Club will pro-rate the total annual fee for a Player on the following basis and issue a refund if deemed appropriate, depending on when the injury was sustained, any/all refunds will be after the players team season has ended.

Any Season-ending Injury Sustained during a Glenbard Hockey Club scheduled practice or game between September 1st to October 1st, 33% skater/goalie fee will still be due. Any Season-ending Injury Sustained during a Glenbard Hockey Club scheduled practice or game between October 2nd to December 31st, 50% skater/goalie fee will be due. Any Season Ending Injury sustained during a Glenbard Hockey Club scheduled practice or game after January 1st, 100% skater/goalie fee will be due. Parent/Guardian and Player understand that failure to meet any of the obligations set forth in this Agreement shall be grounds for suspension of Player's participation in the activities of the Club and team until such obligations have been fully met. In the event your account becomes seriously delinquent, and it becomes necessary for the Club to engage a collection agency to collect your outstanding balance, the costs of collection will be added to your balance.
