

BOBBY HULL ICE RINK
WAIVER AND RELEASE OF ALL CLAIMS
FOR ADULT PARTICIPANTS

This Waiver and Release of All Claims (this "Release") is executed on the _____ day of _____, 20____, by _____, the ice rink participant (the "Participant"). The Participant desires to participate in [select one: _____ RECREATIONAL HOCKEY, _____ SKATING INSTRUCTION, _____ OPEN SKATE] (the "Activity") at the Bobby Hull Community Ice Rink (the "Ice Rink"), which is located at the northwest corner of West 35th Street and South Laramie Avenue, Cicero, Illinois 60804. The Participant acknowledges and recognizes the possible risks associated with the Activity, which include the risk of serious injury or death and assumes full risk and responsibility, during and after the Participant's participation in the Activity, for the Participant's decision to use, at his or her own risk, the Ice Rink facilities, equipment and property, to participate in the Activity at the Ice Rink, for what instructions or information to receive or follow and for the full risk of loss, theft or damage to any property brought into the Ice Rink and/or given to Ice Rink staff members.

FOR AND IN CONSIDERATION of the Participant being permitted to participate in the Activity at the Ice Rink, the receipt and sufficiency of which is hereby acknowledged, the undersigned Participant for himself or herself and for his or her respective personal representatives, heirs, administrators, assigns, executors, administrators, beneficiaries, legatees and next of kin hereby releases, waives, discharges and covenants not to sue the Town of Cicero (the "Town") and its past and present officials (whether elected or appointed), officers, directors, trustees, agents, servants, representatives, attorneys, insurers, volunteers, employees, independent contractors, successors, predecessors and any other party in any way related to the Town and/or the Ice Rink (collectively, the "Released Parties") of and from any and all claims, losses, demands, liabilities, penalties, liens, encumbrances, obligations, causes of action, costs and expenses (including reasonable attorneys' fees and court costs) suits and damages (whether actual or punitive) (collectively, the "Claims") on account of any injury to the person or property of the Participant, including death, that may be caused by negligence of the Released Parties, or otherwise, while the Participant is participating in the Activity or that occurred or is alleged to have occurred, in whole or in part, in connection with the Activity, the Ice Rink, the Town or the Participant's use of the Ice Rink facilities, equipment or property.

To the fullest extent permitted by law, the Participant agrees to and shall defend, indemnify and hold harmless the Released Parties of, from and against the Claims, sustained by the Participant or sustained by others caused, in whole or in part, by the acts or omissions of the Participant, arising out of or in any way connected with the Participant's participation in the Activity or the Participant's use of the Ice Rink.

The Participant expressly agrees that this Release is intended to be as broad as is permitted by the laws of the State of Illinois and if any portion hereof is held invalid, it is agreed that the remainder shall, notwithstanding, continue in full legal force and effect.

This Release applies to all past, present, and future use by the Participant of the Ice Rink.

The Participant acknowledges that he or she is able to speak and read English and has carefully read the contents of this Release or has had this Release translated for him or her and understands the translation. The Participant further acknowledges that he or she is competent, is of lawful age and has not been given any promise or inducement to sign this Release. The Participant further understands that this Release is intended as a complete waiver and release in favor of the Released Parties, that the Participant hereby assumes full responsibility for and risk of property damage, bodily injury for himself or herself and others damaged or injured as a result of the Participant's negligence, acts or omissions in connection with the Activity, the Ice Rink, the Town or the use of the Ice Rink facilities, equipment or property. The Participant further acknowledges that he or she has signed this Release as his or her own free and voluntary act.

THE PARTICIPANT HAS READ THE FOREGOING RELEASE AND FULLY UNDERSTANDS THE TERMS CONTAINED HEREIN.
