

BOBBY HULL COMMUNITY ICE RINK
WAIVER AND RELEASE OF ALL CLAIMS
FOR MINOR PARTICIPANTS

This Waiver and Release of All Claims (this "Release") is executed on the _____ day of _____, 20____, by _____, the minor (the "Minor") and _____, a parent/legal guardian of the Minor (the "Parent"). The Minor desires to participate in: [select one: _____ RECREATIONAL HOCKEY, _____ SKATING INSTRUCTION, _____ OPEN SKATE] (the "Activity") at the Bobby Hull Community Ice Rink (the "Ice Rink"), which is located at the northwest corner of West 35th Street and South Laramie Avenue, Cicero, Illinois 60804. The Minor and the Parent acknowledge and recognize the possible risks associated with the Activity, which include the risk of serious injury or death and assume full risk and responsibility, during and after the Minor's participation in Activity, for the Minor's decision to use, at his or her own risk, the Ice Rink facilities, equipment and property, to participate in the Activity at the Ice Rink, for what instructions or information to receive or follow and for the full risk of loss, theft or damage to any property brought into the Ice Rink and/or given to Ice Rink staff members.

FOR AND IN CONSIDERATION of the Minor being permitted to participate in the Activity at the Ice Rink, the receipt and sufficiency of which is hereby acknowledged, the undersigned Parent, as the parent or legal guardian of the Minor and on behalf of the Minor, and the Minor for himself or herself and for his or her respective personal representatives, heirs, administrators, assigns, executors, administrators, beneficiaries, legatees and next of kin hereby releases, waives, discharges and covenants not to sue the Town of Cicero (the "Town") and its past and present officials (whether elected or appointed), officers, directors, trustees, agents, servants, representatives, attorneys, insurers, volunteers, employees, independent contractors, successors, predecessors and any other party in any way related to the Town and/or the Ice Rink (collectively, the "Released Parties") of and from any and all claims, losses, demands, liabilities, penalties, liens, encumbrances, obligations, causes of action, costs and expenses (including reasonable attorneys' fees and court costs) suits and damages (whether actual or punitive) (collectively, the "Claims") on account of any injury to the person or property of the Minor or the Parent, including death, that may be caused by negligence of the Released Parties, or otherwise, while the Minor is participating in the Activity or that occurred or is alleged to have occurred, in whole or in part, in connection with the Activity, the Ice Rink, the Town or the Minor's use of the Ice Rink facilities, equipment or property.

To the fullest extent permitted by law, the Minor and the Parent agree to and shall defend, indemnify and hold harmless the Released Parties of, from and against the Claims, sustained by the Minor or sustained by others, caused, in whole or in part, by the acts or omissions of the Minor, arising out of or in any way connected with the Minor's participation in the Activity or the Minor's use of the Rink.

The Minor and the Parent expressly agree that this Release is intended to be as broad as is permitted by the laws of the State of Illinois and if any portion hereof is held invalid, it is argued that the remainder shall, notwithstanding, continue in full legal force and effect.

This Release applies to all past, present and future use by the Minor of the Ice Rink.

The Minor and the Parent acknowledge that they are able to speak and read English and have carefully read the contents of this Release or have had this Release translated for them and understand the translation. The Minor and the Parent further acknowledge that the Parent is competent, is of lawful age and has authority over the Minor and neither the Minor nor the Parent has been given any promise or inducement to sign this Release. The Parent and the Minor further understand that this Release is intended as a complete waiver and release in favor of the Released Parties, that they hereby assume full responsibility for and risk of property damage, bodily injury for themselves and others damaged or injured as a result of the Minor's negligence, acts or omissions in connection with The Activity, the Ice Rink, the Town or the use of the Ice

Rink facilities, equipment or property. The Minor and the Parent further acknowledge that they have signed this Release as their own free and voluntary act.

THE MINOR AND THE PARENT HAVE READ THE FOREGOING RELEASE AND FULLY UNDERSTAND THE TERMS CONTAINED HEREIN.
