- Mac Attack Update (ML) 26 Teams participated, 30 full ice games played all refereed. Tournament went well. No complaints were submitted.
- ASHA Board Meeting Recap (ML) On the horizon for ASHA is a changing to the penalties. Charging and Boarding will be treated as Checking from behind. Item is still up for a vote in the July ASHA meeting. Selects will be on December 21 and 22.
- Bantam/Peewee D State Tournament information (ML) Bantam D did not attend but the tournament forgot to put them on the schedule so there was no penalty fine for them. Pee Wee D did not attend and due to a series of mishaps they did get fined for the forfeiture, \$1,000. The \$900 from the Bantam D fee will be used to cover the Pee Wee fine and an additional \$100 will be issued from MHA to cover the balance.
- Ben Boeke outdoor rink (ML) Carlos Gomez will be putting up new outdoor rinks at the end of May. The current rinks will be taken out and set aside until the end of May. Free to anyone who wants them, contact Scotty Gomez Foundation for more information.
- Jersey Samples (KW) 3 house jersey samples were presented to the membership. These are made in America and will be purchased through Play It Again Sports. The estimate shows these jerseys to be about \$20 cheaper than the current version. House teams for mites is still waiting on color assignments so that they can plan their jerseys accordingly.
- SafeSport coordinator (RB) Andrew Good is heading up the SafeSport program. We will need to appoint an MHA coordinator to assure that all guidelines are being met and rules being followed.
