### **Items for Discussion:**

- Beginning of Year Fundraiser (ML) UAA Exhibition game is on hold until UAA has their new coach. Rachel will be the POC for the brainstorming ideas. Possible partnership with Play It Again Sports to combine with USAH to get try hockey for free day in August. Brian will talk with Don and USAH to try and get the ball rolling on this event. Set up carnival types of games outside for fees.
- Letter to Membership about Registration Increase (ML) The ice fees will increase this year, the amount has not been released. It has been speculated for \$270-\$280, we are budgeting for \$290. Need to work budget in May so we can send this letter out in June.
- Will Mites need to attend Tier III evaluations? While the Tier III portion of this division is gone, are we planning on dividing the teams based on skill during registration? (MG) Brian will compose a letter for us to post out to the association. The mites will be separated by ability (red, white, blue). Team size should be around ten players. Red team will be ½ ice 4 on 4, White 4 on 4, and Blue 3 on 3 will be cross ice. After February Red team will have to process a waiver to play five full ice games. We are estimating five full teams. Starting to push ADM (American Development Model) for trainings and games. All mites will need to come to evaluations. The U8 team planning board wants to meet and have a scheduling meeting.
- June's Board Meeting moved to Monday, June 10th or June 17th. (RS/MM) Not moved.
- Proposal to have Board Meetings alternate between the 2nd Wednesday of the month and the 2nd Monday of the month. This way, if Wednesday's are problematic for any of us, we will at least be able to attend Monday's...or visa-versa (RS/MM) Not moved.
