# THE SALAAM CUP – WAIVER, RELEASE, AND CODE OF CONDUCT AGREEMENT

### Participant Acknowledgement and Release of Liability

By participating in any event organized under **The Salaam Cup**, each participant **automatically acknowledges and agrees** to all terms outlined in this Waiver, Release, and Code of Conduct Agreement. This includes full acceptance of personal responsibility for any and all risks, injuries, or losses — including but not limited to physical injury, theft, property damage, or death — whether direct or indirect, that may occur to themselves or any individuals under their supervision during or as a result of participation in any Salaam Cup event (the "Event").

The organizers of The Salaam Cup — including, but not limited to, Salaam Sports volunteers and directors, affiliated sponsors, venue hosts such as the municipally run, and its Parks & Recreation Department, and all personnel involved — shall be **fully released from any and all liability** resulting from injuries, damages, or losses sustained during participation or attendance. This waiver applies to **all claims**, whether arising from negligence, gross negligence, or otherwise, to the fullest extent permitted by law.

### **Property Responsibility**

All participants accept full financial responsibility for any theft, vandalism, damage, or loss caused by themselves or their team to any facility, equipment, trophies, or other assets associated with The Salaam Cup. This includes both public and private property used during the Event. Such actions may result in civil claims, disqualification, suspension, or permanent exclusion from all Salaam Sports events.

### **Media Release**

By participating, individuals grant The Salaam Cup and its authorized partners the right to use, reproduce, and publish photos, videos, or recordings of their likeness taken at the Event for promotional, archival, or commercial purposes in any format, unless written notice is provided prior to the start of the Event requesting exclusion.

#### **Indemnification Clause**

Participants agree to **indemnify**, **defend**, **and hold harmless** The Salaam Cup, its organizers, directors, sponsors, volunteers, and associated entities (the "Released Parties") from any and all liabilities, claims, demands, actions, or causes of action, including legal fees and costs, arising out of or related to participation in the Event or violation of any rules or laws.

## **Code of Conduct and Disciplinary Action**

All participants are expected to act in accordance with the highest standards of **sportsmanship**, **Islamic character**, **and respect**. Any form of misconduct — including verbal abuse, threats, harassment, physical altercations, or unsportsmanlike behavior — will result in **immediate disqualification** and may lead to **suspension**, **lifetime bans**, and/or legal consequences.

Participants agree to comply with all rules and regulations issued by The Salaam Cup organizers and facility managers, whether written, verbal, or implied. Failure to comply may result in removal from the tournament, forfeiture of games, and disqualification from current and future events. All disciplinary decisions made by tournament officials are final and binding.

By participating in The Salaam Cup, all individuals confirm that they have read, understood, and agreed to the terms of this Waiver, Release, and Code of Conduct Agreement. No additional signature is required.
