# Coach Cordinator Craig Cameron (not present but submitted a written report)

Four clinics were held in the region this fall:

- Elkhorn hosted both the initiation and coach awareness clinics on Sunday Oct 5, 2003.
- Brenda Orr informed me that both were well attended, 20-25 people at each.
- Hosting 2 half day clinics on the same day in one town worked well.

- Hamiota hosted the coach level clinic on Saturday Oct 4, 2003 which was well attend with approximately 25 participants.

- Hamiota also hosted a safety clinic on November 29, 2003 which should probably have been cancelled as only 4 people attended, difficult to cancel on short notice.

- The problem may have occurred as many teams already had safety people in place by allowing them to attend clinics in other regions.
  - Safety clinics should be held during the first week in October, the same as the other three. I will attempt to get early dates for all clinics next year.
