Dan Johnson gave the Director's Report:

Very busy fall with O/A and Transfers. Many thanks to registration committee for timely responses to the emails requesting votes.

A number of transfers were required after the player had already registered in another Association. I sent out a note at the beginning of the season that addressed this. Not to stop players from moving but to ensure that players are properly registered. We have an ongoing one in female with Neepawa right now that is yet to be resolved. 2 Appeals this season: Adam Robidoux won and Jocelyn Zimmer won. Parkland did not call in on either appeal.

A list of O/A and Transfers was provided by the director. Some listed were denied because the proper process was not followed.

Finances - Treasurer Shirley Wowryk -

Treasurer Shirley Wowryk presented the Financial Statement for Sept 1, 2014 to August 31, 2015.Revenues \$13,371.44, Expenses - \$9150.14. Treasurer Shirley Wowryk presented the Interim Financial Statement for Sept 1, 2015 to December 8, 2015. Revenues \$30,192.67, Expenses - \$29,457.37. Coach Co-ordinator (Bruce Coulter) - report:

- Clinic registration is online finally.

- Clinic in Elkhorn was cancelled - unfortunately participants were not advised.

Referee Co-ordinator (Kyle Moffat) - written report sent:

My apologies for being unable to attend this meeting. I don't have much to report on but the report is as follows: Yellowhead hosted 4 officials clinics in the region this year – the numbers are:

- 1) Neepawa 24 in Level 1 and 2
- 2) Hamiota 9 in Level 1 and 6 in Level 2
- 3) Rivers 8 in Level 1 and 6 in Level 2

4) Minnedosa 41 in Level 3 (note – this clinic had to be expanded twice to accommodate registrants). Another official from the region, Wyatt Rapsky of Minnedosa, was invited to the High Performance clinic this year. This now gives us two officials in the elite (Level IV-VI) range. Please note, all clinics have been closed for some time now, anyone who did not participate in a clinic is now an unregistered official. It has been brought to my attention that certain associations are using unregistered officials for sanctioned Hockey Manitoba games. This is unacceptable. Please realize that by using unregistered officials you have effectively voided all Hockey MB/Hockey Canada provided insurance for everyone participating in that game. As well, we leave ourselves open to a game being protested or appealed as well as potential suspension for that official (which does carry into playing hockey as well).

So far the comments have been mainly positive this year. We've been able to identify some promising young talent throughout the region, which was a primary goal of mine this year. Thanks to all who have assisted with this.
