## **Summer 2025**



We have reserved a block of rooms at the Capt. Thomson's Resort, located at 45 James Street Alexandria Bay, NY 13607.

The reserved nights are Thursday, July 31<sup>st</sup> through Saturday, August 2<sup>nd</sup> (Check out on the 3<sup>rd</sup>).

The High School weigh ins are around 3:30 PM on Friday (August 1<sup>st</sup>) and finishes in the afternoon on Sunday (August 3<sup>rd</sup>). End time is TBD & based upon how we do in the event, but it could be late afternoon on Sunday.

For the <u>High School</u> group, some families drive up Thursday (the 31<sup>st</sup>), but others drive up early Friday (the 1<sup>st</sup>). You just need to be there by weigh in time (around 3:30 PM on Friday).

<u>Jr High</u> wrestlers eligible are those wrestlers entering 6<sup>th</sup> through 9<sup>th</sup> grade. In addition, the wrestlers entering 9<sup>th</sup> grade are able to wrestle in both events.

For the <u>Jr High</u> group, you will need to be there by Thursday night (the 31<sup>st</sup>), as weigh ins are early Friday morning. The event is just one day and will be completed by about 5 PM. The incoming Freshman class can wrestle in both events, and if you are able to do so you will need to book all 3 nights. Anyone just wrestling in the Jr High event can leave late Friday or stay as long as they want.

To book the room you will need to call <u>315-482-9961</u> or email <u>Lisa@CaptThomsonsResort.com</u> and mention Del Val Wrestling to receive the negotiated rates. You can not get the reduced rate online.

Rooms must be reserved by June 30<sup>th</sup>. Rooms can be cancelled up to 48 hours before the day of arrival.

- Castle View Single & Double occupancy: \$225 Thurs, \$250 Fri, \$250 Sat
- Non-Castle View Single & Double occupancy: \$210 Thurs, \$235 Fri, \$235 Sat
- Check in is at 4 PM and check out is at 12 PM.

\*\*\*I understand many of you are new to the program so if you have questions, please email Coach Fitz anytime. We will be planning lineups for this as the spring/summer progresses. This is the only event all summer where we can't get everyone in as it's a dual meet format. With that being said, many wrestlers and families have attended over the years, even with limited or no bouts. It's just wonderful up there and there is plenty of time for touring and rasslin!

\*\*\*Note that there is a \$45 payment for each wrestler for the registration fee that needs to be paid to the Foundation. This is needed to cover the registration fee, t-shirts, and all items needed for the team at the event.

## **Notes from the resort**

All of your guests will have a private balcony overlooking the St. Lawrence River with rooms that include the following free amenities: Cable TV, Wi-Fi, iron & ironing board, hair dryer, alarm clock, compact fridge/freezer unit, coffee maker & condiments, closet area with hangers, luggage rack, tub and/or shower with toiletries, and a personal heating/cooling unit. King rooms without a Jacuzzi will have a sofa bed with coffee table and most rooms include a desk with an office chair. Your group will have free access to the following property amenities: our Riverside Sun Deck and heated above ground pool (open Memorial Day through Labor Day,) propane fire-pits, brand new docks, a Gazebo facing Boldt Castle and convenient ice machines. During office hours guests can enjoy our lobby with fresh, hot coffee or tea and fruit-infused cold water. Our rooms, balconies, & walkways are non-smoking. Each guest room will be given a copy of our resort rules that are expected to be followed. Incidental fees, such as losing a room key, will be payable at check-out time by your guests. To access the 2<sup>nd</sup> floor, stairs are required. We do not have elevators.

## **RESORT POLICIES**

ROOM RESERVATIONS: *The resort has 2 floors and no elevators.* Our Castle-View Upper Harbor building requires 2 stairs to access the 1<sup>st</sup> floor and 20 additional stairs to access the 2<sup>nd</sup> floor. Guests must specify mobility requirements; based on availability.

CANCELLATION POLICY: Changes or cancellations to meals, boat rides and all ADD-ON's are not possible under 30 days' notice. Individual cancellations require 48-hours' notice for their individual rooms; failure to do so will result in forfeiture of their deposit. All cancelled groups within their policy time frame requesting a refund will be charged at \$10 processing fee.
