- 1. Introduction- Each spring, U.S. Lacrosse, the national governing body for the sport of lacrosse, chooses to recognize student-athletes that excel in both the classroom and on the field. Each US Lacrosse area is afforded a proscribed number of honorees. In 2021, the state of Michigan will have the opportunity to recognize twenty two (22) athletes based on 134 teams competing in the sport of boy's lacrosse.

The information required for the consideration relies on information from Coaches, Counselors, Principals, and the players themselves.

This is a very competitive award so we are unable to accept incomplete nominations. It is the responsibility of each coach to ensure the Counseling and Administrative elements are in by the deadline.

Please note that academic information is through the 5th semester (Juniors) or 7th semester (Seniors), so this portion can be completed any time after the 1st semester of the school year.

You may submit the entire package except the player's game played information. None of this application requires you waiting until the end (except games played, games started, and unsportsmanlike fouls). We can add that after the fact.

The season information will need to be completed at the conclusion of the regular season. We recommend that BEFORE submitting these documents to your Counseling Department, you have the Player fill out the Service portion of the nomination.
