**Treasurer's Report**

- Account currently have a little over \$5000 from registration
- Have brought in \$6355 total from registration with \$150 in Paypal fees
- Still have to pay for league (\$425)
- Will soon be paying 1st installment (\$1000) of PAL (\$2000 total)
- PTWC will offer to Lenape Valley to split cost of Grade School League since we are a combined team.
- Still Need to Pay:
  - PO Box Fees
  - Annual Scale Cert.
  - IRS
- To Date We have already Paid:
  - Domain Name for 3 years
  - USA Wrestling Insurance Cert + Rider of Cert Holders
  - Website (\$235) in July

**Registration Report:**

- Currently we have 53 registrants with 1 K Clinic registration and 2 outstanding payments
- More registration has come in to date this year then at this time last year
- We currently have 1 scholarship athlete

## ***COMMITTEE REPORTS***

### **Tournament:**

- Date for Tournament is set for December 17th at the PAL.
- There will be 2 five team tournaments with an AM and PM Session
- AM session will consist of K-6 & PM session will consist of K-8
- Entry fee for tournament has been lowered from \$350 to \$280 to entice teams.
- One team each session will be PTWC
- Trophies and medals will be awarded for 1st place; medals will be given to 2nd and 3rd place participants.
- 2 mats will run for each tournament with a round robin format
- 2 officials will work each tournament (same officials am & pm) and will be paid \$600 to lessen our official fees for the tournament.
- Idea of only 2 officials per tournament will be run by Tim Wyatt.
- There will be an intermission during each tournament.
- Teams will be allowed to fill empty weight classes with free agents with an optional \$20 per free agent fee.
- Need to discuss with Pete Justo regarding coach to monitor weigh-ins the morning of the tournament.
- Projected financials for the tournament are as follows as per Ralph
  - Concessions - \$750 per session
  - Admissions - \$400 per session
  - 50/50 - \$100 per session

### **Concessions:**

- Last years concession stand profits were \$1900
- Discussion took place regarding cutting back the amount of food at concessions
- Still have limited candy, chips, pizza, Gatorade, and water
- We will be asking parents for Gatorade and water donations to help offset costs
- Also looking for a team mom for each team to help organize

### **Work Bond:**

- Committee will be run by Kerry Krauss and Nati Gregory. Cris meeting with them before Thanksgiving to do transition
- SignUp Genius is being put together based on our listed home events.
- Work Bonds will be filled with putting out/putting away mats, concessions, etc.

### **8th Grade Liaison:**

- Ronnie Petzinger will be the 8th grade liaison.
- She will talk to Pete regarding clothing item for 8th graders
- Discussion about "captain" not being printed on clothing item
- John & Jose wants to present the 8th graders their clothing rather than have parents just give to them.

**Recruiting:**

- There are currently 4 schools left to be visited - Lake Parsippany, Lake Hiawatha, Northvail, and Knollwood.
- 500 cards were printed up to be handed out for PTWC recruitment purposes at a cost of \$140.

**Fundraising:**

- Discussion took place to eliminate the idea of a car wash
- Ideas for fundraising included a Dine to Donate at Chipotle, Canning at Walmart, and the annual Pasta Dinner.
- The idea of Super Bowl Scratch Offs was also presented.
- Kerry Krauss volunteered to organize a Big Brother/Big Sister Clothing Drive fundraiser in January as well.
- Discussion for Pasta Dinner to take place mid-January - specific dates to be discussed further.

**Apparel:**

- Looking to have apparel available as holiday gifts
- Will use Class Act
- Kim Doktor will meet with Cris to discuss format for sales

**Uniforms:**

- Pat Rocco would like to prepackage uniforms instead of passing out uniforms as we have in years past.
- Weights will be taken during the 1st week of practice to identify uniform sizes needed for athletes and will receive his or her uniform after this takes place.

**Parent Meetings:**

- JV/V Meeting will take place on November 16th during practice

**New Business:**

- We need to have training sessions on both clocks and the book for additional parents
