Recruiting Report

School Visits: Need to schedule and get coaches to commit to participate. June will contact Tony DeIntinis to help present along with Coach Lodato (BMS) and Coach Hernandez (CMS). June will contact the schools with appropriate dates – last 2 weeks of September and first two weeks of October (September 19 – October 14).

Its important PTWC maintain a working relationship with the middle school coaches in order to have them recruit for PTWC. All middle school wrestlers should be rostered on PTWC pre-season rosters with the hope they join. This will alleviate any issues will adding them to a roster, time allowances, etc. Gabe and Dan confirmed this is common practice for both North Jersey and Grade School leagues, respectively.

Having a "Open Mat Trial Week" within the first couple weeks of practice was discussed in order to accommodate kids who may be on the fence with joining. Insurance issues are at the forefront (as those kids will not have a USAW Card.) Kim offered a suggestion to June to contact our insurance company and request information on a temporary inclusion or rider to the policy for a small window of time to accommodate these kids. June is investigating.

Fundraising Report

Annual Holiday Tournament: Saturday, December 17th. PAL is booked for full day (APR and Gym). Discussed pros and cons of various ideas – team vs individual tournament, confirming teams, advertising, etc. Date will likely overlap with other traditional local tournaments (Chatham and Montville mentioned) and this could pose a problem. June will create and present a flyer to the full roster of coaches attending the Northern NJ League meeting on September 21 in order to generate interest.

Other ideas presented: Pasta Dinner, Buffalo Wild Wings. A Pep Rally Season Kick-Off Pot-Luck was suggested and met with positive response. Mike is familiar running this event. Nick suggested a car wash and offered the Elks Club building location.

Committee Reports

The following committees need to be filled by parents. These are non-voting Executive Board positions. Concessions, Work Bond, 8th Grade Liaisons, Recruiting, Fundraising, Apparel, Uniforms, Webmaster, Scheduling Coordinator (work along with June), Referees, Tournament. Cris will agree to continue as Registration Coordinator for the season as its already in progress.

<u>General</u>

Parent Meeting will need to be planned for the start of the season. Conduct within the first week or two of practices.

2016-2017 Coaching Program

After much discussion, June introduced Pete Justo as the new Head Coach of PTWC. Motion was made by Cris: Pete Justo will be appointed the Head Coach of PTWC for the 2016-2017 season. The position will be a non-voting Board of Directors position within the Executive Board.

Motion approved by Ralph Rocco, seconded by June Madia. All in favor: 4 Against: 0

Discussion

- Pete knows the sport: he wrestled throughout high school and college. He continued after college and coached teams to championship levels.
- Pete has a vested interest: he is from Parsippany, does not have a child involved, is a former PTWC coach, is a local resident with the ability to do a great job and more importantly, is anxious to see PTWC turn-out a great group of wrestlers to PHS and PHHS.
- Philosophy consists of setting up a very consistent structure for instruction and discipline. PTWC needs to build very strong basics and do them well. This is a program full of young wrestlers who will be taught proper technique so as they grow and mature as athletes, the skills will follow them.
- Largest focus this season is to get the kids involved in the sport and want to come back and do it again, even have them work off-season to continue developing.
- Wrestle-Offs between team members will happen. Pete and the coaches will work out a plan and present it to the wrestlers and parents by the start of the season. Our current wrestle-off plan in the by-laws needs revamping but this section will be updated and in place. Cris working on by-laws and will include this information as it is received.
- Practice Requirements: details needs to be worked out but Pete is strongly suggesting 4 to 5 nights of practice a week until competitive season begins. Agreement among those present. June is working out locations and times and will get the information finalized. As soon as possible, the information will be posted to the website and members will be made aware of the schedule.
- With regard to kids who choose to participate in an outside club or team along with participating with PTWC, it was discussed using the current by-law standard. This is still up for discussion and resolution but it was made clear by Pete and Dan that in no way will a "club wrestler" be given priority or a "guaranteed spot" in any weight class on any team. It was also discussed that PTWC practice attendance will be required and mandatory by "club wrestlers" but each case will be discussed and decision made with the best interest of the team and all wrestlers involved being taken into consideration.
- It was also discussed kids participating with PTWC along with either the BMS or CMS team will not be required to attend PTWC on nights after a school match, but it will be encouraged that efforts be made to attend PTWC on those nights as well (discussion included that the middle school matches aren't always challenging or productive.)
- Pete is creating a coaching syllabus/outline to use in the first month of practices. He is looking for input from the coaching staff and wants to work together.
- Pete will commit to attending practices one night a week to participate and work out. He generally will not attend on Wednesday evenings due to personal commitments.
- Practice room will include:
 - Varsity and Future Stars working together at practices: this brings a large group of kids to work together. Less experienced kids have the advantage of learning from more experienced kids and those more experienced kids get the advantage of helping others learn more.
 - KOM and Kindergarten Clinic kids working as separate groups (KClinic only on Saturdays)
 - o Group Instruction: full group will watch move being taught, listen to discussion, ask questions
 - Break-Out Groups: kids will break out in to groups of 3-5 kids based on weights, be monitored by a Coach, and work on the move. Coach will correct and redirect until fluency is achieved.
 - Live Wrestling, Drills, and Wrestle-Offs
 - Conditioning will be a major factor during practices and a top priority for PTWC

- At the upper levels no more dodge ball, football, climbing walls, running in and out, etc. A strong discipline and consistent behavioral approach will be used by all coaches in the room.
- o 75-90 minutes of hard and fast work for the kids. Arrive on time or there will be consequences.

- Grade School: PTWC does not have the numbers to roster a team this season. The League has made
 an exception and will allow PTWC wrestlers to fill in weight classes on Long Valley's team. At this time,
 we are not sure how this team will be rostered (PTWC fill-ins vs PTWC/Long Valley combined team with
 wrestle-offs). June is under the impression PTWC will be included on a fill-in basis and therefore have no
 responsibility to host events or pay fees to the league. John will contact Kevin and receive more
 information on the process being considered.
