TO ALL CREDITORS AND PARTNERS OF CORNERSTONE CAPITAL INC., AND OTHER PARTIES IN INTEREST:

PLEASE TAKE NOTICE that on April 13, 2021, Cornerstone Capital Inc., a Delaware corporation (“Cornerstone” or the “Company”) established a Liquidating Trust known as the Cornerstone Liquidating Trust (the “Liquidating Trust”) and appointed RC Cornerstone Trust CO, LLC as Trustee of the Liquidating Trust (the “Liquidating Trustee”).

PLEASE TAKE FURTHER NOTICE that also on April 13, 2021, Cornerstone assigned all of its assets to the Liquidating Trust for the purposes of conducting an orderly liquidation of its remaining assets for the benefit of creditors, partners, and other parties in interest, all as set forth in a Liquidating Trust Agreement dated April 13, 2021 (the “Liquidating Trust Agreement”).

PLEASE TAKE FURTHER NOTICE that pursuant to the Liquidating Trust Agreement, the Liquidating Trustee has no personal responsibility for the liabilities of Cornerstone but is merely acting in a fiduciary capacity to liquidate the assets of Cornerstone that were transferred to the Liquidating Trust for the benefit of creditors and other parties in interest as set forth in the Liquidating Trust Agreement. A true and correct copy of the Liquidating Trust Agreement can be downloaded from the following website www.trustee-claims.com. Pursuant to the Liquidating Trust Agreement, Cornerstone transferred to the Liquidating Trust ownership of all property of Cornerstone of any kind or nature, including all real property, all personal property, all assets, equitable or legal rights or interests, contract rights, benefits, causes of action, claims, cash, accounts, deposit accounts, accounts receivable, payment intangibles, or any other thing tangible or intangible, of any kind whatsoever, owned or held by or on behalf of Cornerstone in which Cornerstone has any right, title or interest on April 13, 2021 (the “Liquidating Trust Assets”).

PLEASE TAKE FURTHER NOTICE that all persons or entities asserting any claim against Cornerstone must submit a proof of claim and proper supporting documentation no later than September 30, 2022 (the “Bar Date”).
