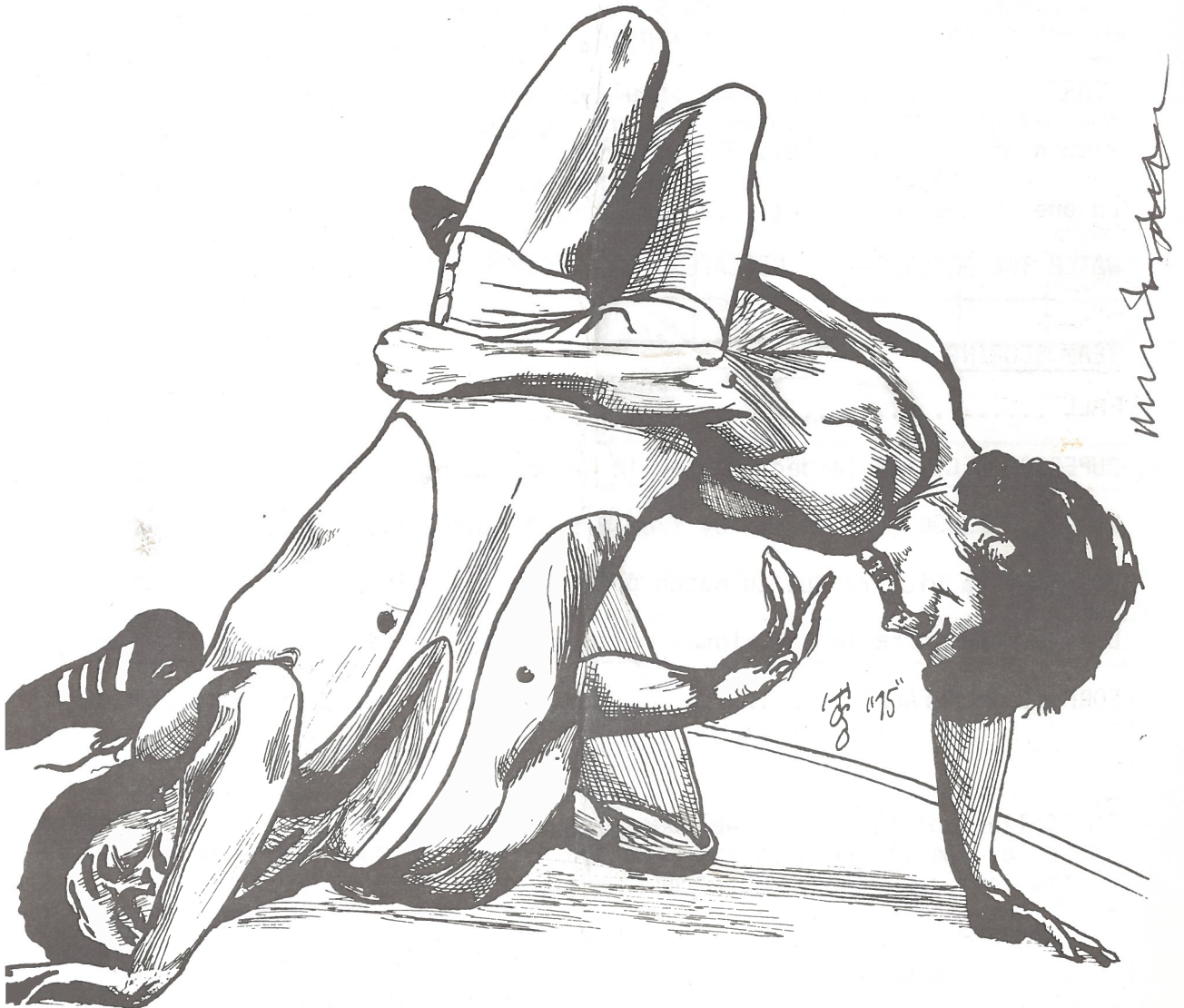

INDIVIDUAL MATCH POINTS

TAKE DOWN (2 pts.) From the neutral or standing position, when a man brings his opponent to the mat and gains control.

REVERSAL (2 pts.) From the referees position, the defensive man gets out from underneath his opponent and gains control of him in one maneuver.

ESCAPE (1 pt.) From the referees position, the defensive man gets out to a neutral position where neither wrestler has control.

FALL or PIN (ends match) Occurs when any part of both shoulders, or areas of both scapulas, are held in contact with the mat for one second.

NEAR FALLS (2 pts.) When both shoulders are held within four inches of the mat or when one shoulder is touching the mat and the other is held within 45 degrees or less with the mat.

(3 pts.) When the offensive wrestler holds the defensive man in one of the above mentioned positions for 5 or more seconds.

WATCH THE REFEREE--HE INDICATES THESE POINTS AS THEY ARE SCORED.

TEAM SCORING

FALL	6 pts.
SUPERIOR DECISION (a decision by 12 or more points).....	5 pts.
MAJOR DECISION (a decision by from 8 to 11 points).....	4 pts.
DECISION (a victory due to match points).....	3 pts.
DRAW (a tie score in individual match points).....	2 pts.
FORFEIT or DEFAULT	6 pts.
