## Clinic Philosophy

Player development will occur when technical ability, tactical understanding and physical fitness are trained in a positive, challenging and competitive environment. This clinic has been designed to teach each player how to fully reach his potential through a demanding week of functional training exercises that teach individual techniques and tactics. This clinic's objective is to develop players who will respond to the challenges of the game in a confident and creative manner. Each day, small sided games will be played to challenge all players in a competitive environment. The small sided game method is used so that each player gets more touches on the ball. This method will enable players to have more time on the ball, to improve their field awareness, to help their decision making and to increase their ability to read the game and anticipate the play.

## Clinic Director

**Paul Vasconcelos** is in his thirteenth year as head coach for the **women's soccer team at Lesley University**. He is the all-time winningest coach in Lesley soccer history and posts an 213-58-18 overall record (96-2-2 NECC).

Vasconcelos and his staff guided the Lynx to their eighth New England Collegiate Conference title in 2019 and returned to the NCAA Tournament. 2019 also marked the ninth time (2008, 2009, 2010, 2011, 2014, 2015, 2017, 2018, 2019) in Vasconcelos' career that he was voted Conference Coach of the Year by his peers.

He has compiled a .797 winning percentage which puts him in the top 10 winningest-active coaches in NCAA history and appeared in twelve straight NECC Championship games.
