2. Players must participate in all team functions, practices, team meetings, teambuilding events and fundraisers, unless excused by the manager. Tournaments may be scheduled for every weekend from mid-May through mid-July (See Tournament Schedule Above). All-Star players are expected to participate in ALL tournaments throughout the All-Star season. At the individual team manager's discretion, practices may be scheduled for every day during the week. All-Star players are expected to make every reasonable attempt to participate in all team practices throughout the All-Star Season.

3. Participation in other activities (i.e. other sports, family vacations, etc.) that will directly conflict with an All-Star player's ability to give 100% commitment to her team is not acceptable. Prior to accepting an All-Star nomination, a choice MUST be made by the player and parents as to which activity is the most important. If All-Star softball is determined to be the most important activity, full participation is required.

4. Players are not guaranteed any specific playing position on an All-Star team, nor are they guaranteed any playing time. Positions and playing time is at the manager's discretion.

5. Participation on an AGSA All-Star team involves travel. As a member of the All-Star team, the player's parent or guardian is responsible for all travel, overnight accommodations, and meals associated with these events. Participation on an AGSA All-Star Team involves a minimum financial commitment of approximately \$350 for uniforms and tournament fees. Payment must be made in full on May 3, 2024. NO REFUNDS will be given; the only exception may be for an injury (tournament fees only). Additional financial costs could potentially range from \$2,000-\$5,000 depending on the level of tournament play achieved by a particular team. Any team that qualifies for Nationals will cause the financial costs per player to potentially reach the higher end of this estimate. Fundraising opportunities may be available but are not guaranteed.

6. I have read and agree to abide by the AGSA Rules as well as the AGSA By-Laws, including the section on All-Stars and Conduct.

7. I understand that by signing below, my daughter is not guaranteed a position on an AGSA All-Star Team, but will be placed on the list for consideration.
