

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.alpinesoftball.com and Alpine Girls Softball Association and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Alpine Girls Softball Association include www.alpinesoftball.com and AGSA. The AGSA website is a Youth sports league site. By using the AGSA website, you consent to the data practices described in this statement.

Collection of your Personal Information

AGSA may collect personally identifiable information, such as your name. If you purchase AGSA's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by AGSA. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the AGSA website.
