Finances-

- Opening balance as of January 1, 2021 is \$4,634.15.

Reviewed and approved MCGFL Registration Fees for 2021:

- 8U – \$50 per team (NO game umpires, medal awards for tournament)
- 10U - \$250 per team
- 12U & 14U - \$300 per team
- 18U - \$250 per team (TBD if we join LC league again)

Umpire Fees for 2021 Season: (Confirmed by Bob Germano per email, expect price increase in 2022)

- 10U - \$20 per team (\$40 Total for 1 umpire)
- 12U - \$25 per team (\$50 Total for 1 umpire, *** can request 2nd ump. and pay same as 14U)
- 14 & 18U - \$40 per team (\$80 Total for 2 umpire)

Confirm community Representatives for 2021.

- Still need communities to confirm contact information. Joe will send email with 2020 contact list for community representatives to send updates to Jackie Jones to update 2021 Contact list.

Communities must start signup in January and/or February to give final team counts at March meeting. They need to get USA Insurance for all players, completed the COVID-19 Liability Waiver form per each player family and MC Coaches Code of Conduct form for any coach.
