

**Assumption of the Risk and Waiver of Liability and  
Release for Guest Teams (the "Agreement")**

**LIABILITY RELEASE:** I, my coaching staff, volunteers, and players, whom are all parties and signatories to this Agreement (collectively, the "**Guest Team**"), assume full responsibility for the risk of injury, death or property damage (including reasonable costs that may be incurred as a result thereof) due to or that may result from the Guest Team's participation in any River City Venom ("**RCV**") softball scrimmage, game or event held at **522 Brownsdale Road, Renfrew, PA** (hereinafter the "**Brownsdale Facility**") ("**RCV Event**"). The Guest Team further agrees to release and to hold harmless the owners of the Brownsdale Facility, Keith and Connie Nicklas ("**OWNERS**") from any and all actual and potential, known and unknown, suspected and unsuspected liabilities and damages, whether caused by negligence or otherwise, excepting gross negligence by OWNERS, for any claims, cause of action, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the Guest Team's participation in an RCV Event at the Brownsdale Facility. The Guest Team further expressly agrees to indemnify and hold harmless OWNERS, their family, heirs, successors, executors and administrators against loss, including reasonable costs related thereto, from any claims, demands or actions that may be brought by any other persons for damages of any nature caused to the Guest Team while participating in an RCV Event at the Brownsdale Facility.

**MEDICAL RELEASE:** The Guest Team acknowledges and agrees that the Guest Team's participation in an RCV Event at the Brownsdale Facility subjects its players to the possibility of physical illness or injury (minimal, serious, catastrophic and/or death) and the Guest Team acknowledges that it is assuming the risk of such illness or injury. In the event of such an illness or injury, the Guest Team authorizes RCV and/or OWNERS to obtain necessary medical treatment for any injured person of the Guest Team and releases and holds them both harmless. The Guest Team further acknowledges and understands that any such injured person will be responsible for any and all medical and related bills that may be incurred.

The Guest Team, by and through the undersigned, AGREES that it HAS CAREFULLY READ AND UNDERSTANDS THIS AGREEMENT AND THAT NO ORAL REPRESENTATIONS, OTHER STATEMENTS OR INDUCEMENT HAVE BEEN MADE. BY AGREEING TO THIS AGREEMENT, VALUABLE LEGAL RIGHTS ARE BEING GIVEN UP AND THIS AGREEMENT IS SIGNED FREELY AND VOLUNTARILY.
