Meeting called to order 11:40 am

Agenda:

1. Approval of Last Board Meeting Minutes: All action items from the Feb 4, 2025 meeting have been completed and the meeting minutes were approved.
2. Treasurer's report: Ann Courchane reviewed the 1Q2026 financial reports which were approved by the board. Craig to upload the financial reports to the 3Score website. Joe Incorvia has agreed to perform the yearly independent review of the financial accounts for 2025.
3. Appreciation Banquet: 3Score funds of approximately \$2,244 were used for the 2026 Appreciation Banquet. A motion was made and approved by the Board to request the Banquet committee to pursue identifying and reserving a date for next year's banquet.
4. Whiskey Wings Social: There were ~35 attendees at the social on March 23rd. A good time was had by all and Joe DeChiaro was recognized for his effort to pull this event together and the work he is doing as Social Activities lead.
5. Committee positions: Craig to update the 3Score Website to remove Greg Stevens and Mark Margolis from the Banquet Committee. NL to review their members on the Rules committee and consider adding a 3rd member.
6. Modifying player punishments: A player has appealed to the board their previous permanent punishment preventing them from being considered as a team captain at any time in the future. The decision by the Board at their June 2025 meeting remains in effect – a player with a permanent punishment should be allowed to make an appeal once 2 years has passed since returning to play after their suspension. The Board will review each appeal on a case-by-case basis, considering items such as: the reason for the initial permanent punishment and the behavior and conduct of the player over the previous two years. This appeal and review is only for the positions of team captain and bench coach.
7. Bay Care games April 10th: No NL or AL pick-up games will be scheduled on this day.

8. Volunteers required: 3Score volunteers will be required to assist with two upcoming tournaments. Sun Conference April 30 – May 2, score board operators. FCSSA May 12 – 16, score board, ball shaggers, ticket scanners, wrist bands, gate monitor.
9. Article V – NOT FOR PROFIT CORPORATION: Craig to fix the type adding “...(c)...” between 501 and (3) non-for-profit organization.
10. NL/AL Ambassadors: NL and AL to consider having two individuals from each league play in the other league during the pick-up games on the first Friday of each month to support camaraderie between the two leagues. Players selected should be at an appropriate skill level for playing in the other league.
11. ECM Fields 1-4 renovation closing: The projected renovation closing is March 2027 – February 2028. Options are being pursued for alternate playing fields during this time.
12. Next Board meeting dates: Tentatively scheduled for June 3rd.
