- 1. Treasury Report Ann Courchane

# Key Discussion Topics:

# National League Umpire Discussion – (Mike Allen)

- 1. Program is going well with umpires Dave Furst and Don (Cubbie) Kutchinski. There is minimal arguing, and they are making accurate calls.
- 2. Mike Allen talked about needing to get more quality umpires. We need to figure out how to do this, as there is not availability for M-W-F mornings.
- 3. Is there enough money to keep this program going after this year? Probably not, but we need to move forward. NL will figure this out before the end of the year.
- 4. Bob Studwell will take over the umpire spreadsheet and money while AI is serving his suspension.
  - a. Jack will send the spreadsheet to Bob
- 5. Mike advised he is actively looking for more umpires; what does he need to do?
  - a. Jack will send the W-9 tax form and the ISA Umpire's insurance form to Bob Studwell
  - b. Bob will print these forms out and have the umpire candidate complete the forms
  - c. Bob will send the forms back to Jack to send to the insurance company. Bob can scan and email directly to Jack or give to Cindy to scan and email to Jack.
    - i. Ann keeps the W-9's on file
  - d. Mike asked Jack to call the insurance company to get a smooth quick system set up. Jack advised once he gets the completed forms, he will send in right away and then it should take less than a week to complete by the ins. co.
  - e. If NL finds volunteer umpires within the league, they must sign a waiver and pay dues before they can take the field.
  - f. If an outside 3 Score umpire volunteers, he still needs to complete the insurance form and W-9 form. The insurance company requires it. If the volunteer receives under \$600, the 1009 form will not be sent to the IRS.
